117.01 *Bills declared referred to Federation Chamber*

Shortly after 12 noon on Tuesday 27 May, prior to the resumption of debate on Appropriation Bill (No. 1) 2014-2015 and four related bills, the Chief Government Whip declared that at 1.30 p.m. that day, the bills were to stand referred to the Federation Chamber for further consideration.

117.02 *Fewer than five Members vote on one side during division; bills passed cognately*

On Wednesday 28 May, a cognate debate resumed on the second reading of the Tax Laws Amendment (Temporary Budget Repair Levy) Bill 2014—to which a non-aligned Member had moved a second reading amendment—and 14 related bills. When the question was put on the second reading amendment, a division was called. Four Members (non-aligned) voted on the side of the “ayes”. There being fewer than five Members on one side, the Chair declared the question negatived without completing the count and the names of those in the minority were recorded in the Votes and Proceedings. Pursuant to the resolution of 15 May (*see entry 116.10*), one question was put on the second reading of the 15 bills and was carried on the voices. Each of the bills was read a second time. One question was then put on the third reading of the bills, also in accordance with the resolution, and was carried on the voices. Each of the bills was read a third time.

The Parliamentary Secretary then moved that the consideration in detail of the bill be made an order of the day for the next sitting and the question was agreed to. The Federation Chamber was then adjourned until the following day.

After asking a question to the Speaker on Tuesday 27 May (*see* entry **117.32**), the Leader of the House moved, without notice, a suspension of standing orders to require the Manager of Opposition Business to immediately apologise to the Speaker for reflecting on her in relation to the holding of a party fundraiser in the Speaker's dining room. Debate ensued and the suspension motion was agreed to on division by an absolute majority, as required. The Leader of the House moved the substantive motion and debate ensued. While the Shadow Minister for Infrastructure was addressing the motion in response, the Leader of the House moved a closure of question which was agreed to on division. The substantive motion was then agreed to on division and the Manager of Opposition Business was given the call in accordance with the resolution. The Member stated that he had dealt with the terms of the motion during his earlier speech. The Speaker said she did not accept that the Manager of Opposition Business had apologised but stated that she hoped that the motion would bring about more decorum in this Chamber.

117.15 Use of placards during question time

During question time on Tuesday 27 May, a number of Opposition Members held up placards whilst the Prime Minister was answering a question on the Budget. The Speaker asked the Members to desist, stating that placards were not permitted to be used. Shortly after, the Prime Minister was answering another question on the Budget and placards were again raised. The Speaker repeated her ruling and advised the Manager of Opposition Business to inform those Members to comply with the ruling. The Manager of Opposition Business then raised a point of order requesting that the same rule apply to the Prime Minister who was waving a document around. The Speaker advised that if the Prime Minister did so again he would be asked to desist.

Later during question time, the Manager of Opposition Business raised a point of order to suggest that the Member had returned in less than an hour and in that case further disciplinary action should be taken. The Speaker, after consulting with the Clerk, was satisfied that the Member had been absent from the Chamber for one hour.

117.17 *Statement by the Speaker on the display of posters in corridors*

After the acknowledgement of country and prayers on Monday 26 May the Speaker made a statement regarding a question asked of her about the placement of posters in the corridors of Parliament House (*see* entry **116.17**). The Speaker stated that, consistent with longstanding practice, upheld by successive Speakers, signs and posters were not permitted in the corridors or on doors leading off the corridors. Where posters had appeared on the outside of doors to Members' suites, the Members concerned had been asked to take the posters down. The Speaker added that 'all Members are entitled to use their suites for their own purposes, but of course not for illegal purposes.'

117.23 *Manager of Opposition Business raises matter of privilege; motion to refer matter to Committee of Privileges and Members' Interests negatived*

After question time on Monday 26 May, the Manager of Opposition Business raised, as a matter of privilege, whether the Speaker had used her Parliament House dining room to hold Liberal Party fundraisers and whether this constituted an improper interference with the operations of the House of Representatives. The Speaker ruled that the Manager of Opposition Business was entitled to write directly to the Committee of Privileges and Members' Interests about the matter. The Manager of Opposition Business then moved a motion, without notice, that the matter be referred to the Committee of Privileges and Members' Interests, and debate ensued. The motion was negatived on division.

The Leader of the Opposition rephrased his question and the Speaker ruled that it was still out of order and called on the next questioner.

The Acting Prime Minister stated that for the remainder of the week, he would answer questions on the Prime Minister's behalf.

The Speaker advised that she would uphold those rulings so that: only the Member speaking or, at question time, the questioner may seek leave to table a document, and only after the Minister had concluded his or her answer; a request by a Member for leave to table a document would not be put where the document was already on the public record; and a request by a Member for leave to table a document would not be permitted when used to disrupt.

The Speaker agreed that it would be suitable if the Manager of Opposition Business did apologise. The Manager of Opposition Business did not apologise so the Leader of the House immediately moved a suspension of standing orders to require the Manager of Opposition Business to apologise immediately (*see entry 117.08*).

117.35 *Member asks Speaker to intervene under standing order 68*

During question time on Monday 2 June, when responding to a question without notice from a Government Member, the Minister for Health repeated information which a Shadow Minister had previously sought to correct by personal explanation. The Manager of Opposition Business raised a point of order requesting that the Speaker intervene under standing order 68, noting that 'currently there is no precedent'. The Speaker stated that she would consider the implications of standing order 68 rather than ruling on it immediately, and gave the call to the Minister for Health.

Note: Standing order 68 was amended at the beginning of the 44th Parliament to provide that: ‘If a Member has given a personal explanation to correct a misrepresentation and another Member subsequently repeats the matter complained of, the Speaker may intervene.’

117.36 *Question to Speaker regarding use of CCTV footage in Parliament House and the searching of Members’ suites*

At the conclusion of question time on Tuesday 3 June, an Opposition Member asked the Speaker whether she approved of, or had any say over, CCTV footage in the House of Representatives corridors being used for non-security related purposes and whether Members’ Parliament House suites could be searched at any time. The Speaker indicated that she would take the question on notice and come back to the Member with a response.

Prior to question time the following day, the Speaker responded to the Member, stating that Members’ offices could not be searched without the permission of the relevant Member, except where a search warrant was executed by police in respect of a Member. She also confirmed that access to CCTV footage is governed by a policy that is publicly available on the Australian Parliament website, but for the convenience of Members she would ensure a copy of the policy was delivered to each Member’s suite later that day.

117.37 *Statement by Speaker regarding the repetition of matters corrected by a personal explanation*

At the beginning of question time on Wednesday 4 June, the Speaker made a statement outlining the approach she proposed to adopt with respect to an alleged misrepresentation being repeated after a Member had sought to correct it by a personal explanation. The Speaker outlined the approach, which would be re-evaluated after a period, as follows:

“if a Member makes a personal explanation to correct a specific personal matter which the Member claims is a misrepresentation and another Member subsequently repeats the same words that have been the subject of the misrepresentation then:

- the Member who made the personal explanation can make a complaint to the Chair about the misrepresentation being repeated;
- the Chair in these circumstances may ask the offending Member to refrain from repeating the misrepresentation;

- in asking a Member to refrain the Chair will not be making any judgement on the truth or otherwise of the alleged misrepresentation or the correction;
- should the Chair intervene, the Member making the complaint will not have the opportunity to subsequently make a personal explanation on the matter; and
- should the Member elect not to seek to invoke standing order 68 and have the Chair intervene, a personal explanation would still be available.”

117.38 *Member requests Speaker’s intervention after Minister repeats matter corrected by personal explanation*

During an answer by the Minister for Health to a question without notice on Wednesday 4 June, a Shadow Minister raised a point of order drawing attention to the Speaker’s statement regarding standing order 68 (*see* entry **117.37**) and requesting that the Speaker intervene on the basis that the Minister was repeating information she had earlier sought to correct by personal representation. The Speaker responded that there was no cause for intervention, and reminded the Member that if she desisted from seeking an intervention she would be able to make a personal explanation later, and gave the call to the Minister for Health to continue his answer.

The Chair gave the call to the Parliamentary Secretary and asked that he take into consideration the requirements of standing order 68 as explained earlier that day in a statement by the Speaker (*see entry 117.37*).
