127.01 *Presentation of 2015-2016 Budget*

On Tuesday 12 May, after a suspension of sitting from 5.58 pm to 7.30 pm, the Speaker reported a message from the Governor-General recommending an appropriation for the purposes of Appropriation Bill (No. 1) 2015-2016. The Treasurer then presented the bill, moved the second reading and delivered the budget speech. During his speech the Treasurer presented two pieces of draft legislation. Debate was then adjourned and the Parliamentary Secretary to the Minister for Finance presented documents in connection with the Budget.

The Parliamentary Secretary then presented Appropriation Bill (No. 2) 2015-2016, Appropriation (Parliamentary Departments) Bill (No. 1) 2015-2016, Appropriation Bill (No. 5) 2014-2015 and Appropriation Bill (No. 6) 2014-2015. The introduction of each bill was preceded by a message from the Governor-General recommending an appropriation for the purposes of the bill.
