17.01 Motion to suspend standing orders regarding comments by private member

On Tuesday, 2 February, the Shadow Minister for Health and Ageing moved to suspend standing orders to allow him to move a motion calling on the Prime Minister to condemn comments made by the Member for Hughes. The mover and seconder were both closured on division and the debate was closured on division. The question on the suspension motion was put and, a division having been called for, the division was deferred in accordance with standing order 133. The motion was later disagreed to.

On the first sitting of the year, the Prime Minister moved that the House acknowledge the death of former Governor-General, Major General the Honourable Philip (Michael) Jeffery and place on record its appreciation of his long and meritorious public service. The Leader of the Opposition seconded the motion and all members present rose in silence as a mark of respect. The motion was then referred to the Federation Chamber. [Watch]

The Leader of the Opposition seconded the motion and the Deputy Prime Minister spoke in support. All members present then rose in silence as a mark of respect. The motion was referred to the Federation Chamber, where it was debated the following day. [Watch]

Questions

17.09 Questions ruled out of order

During question time on 2 February, the Shadow Minister for Health and Ageing asked the Prime Minister if he would condemn remarks made by the Member for Hughes. The Speaker ruled the question out of order, noting that the Prime Minister was not responsible for comments made by private members.

The following day, another two questions to the Prime Minister concerning the Member for Hughes were ruled out of order. The Speaker explained that, under the standing orders, ministers could only be asked about matters for which they have direct ministerial responsibility. Further, questions could not reflect on or be critical of the character or conduct of a member. He added that there were other opportunities for members to raise such matters in the House.

17.10 Question to committee chair

On 3 February, an opposition member asked the Member for Hughes a question without notice in his capacity as chair of the Parliamentary Joint Committee on Law Enforcement. The question asked when the committee's report on law enforcement during COVID-19 would be tabled and referred to recent public statements made by the member.

The Speaker noted that questions to committee chairs during question time were limited to matters of timing and procedure and directed the chair to respond to those aspects of the question.

During question time, a member may ask a question (limited in scope) of a member who is not a minister. The question must relate to a bill, motion or other business of the House or of a committee, for which the member asked is responsible. Such questions are uncommon.
