18.01 Prime Minister's statement on anniversary of national apology to the Stolen Generations

On the first sitting of the fortnight, the Prime Minister made a ministerial statement on the anniversary of the national apology to the Stolen Generations made by Prime Minister Rudd on 13 February 2008 and presented a copy of his statement.

The Leader of the Opposition spoke in response and the Leader of the House moved that the House take note of the statement. The Minister for Indigenous Australians and the Shadow Minister both spoke to the motion. [\[Watch\]](#)

Later in the day, the Prime Minister and the Leader of the Opposition both made statements by indulgence in remembrance of Ms Clarke and her children.

As with similar agreements made between the Leader of the House and Manager of Opposition Business over the last year, the agreement allowed for members unable to attend parliament for reasons related to the pandemic to participate in proceedings remotely via the official video facility.

Over the fortnight, three members participated in proceedings remotely. This included the first contribution made in the Federation Chamber via video link.
