## Bills

### 23.01 COVID-19 response bill introduced and passed all stages in one sitting

On the first day of the sitting fortnight, the Assistant Treasurer, by leave, presented the Treasury Laws Amendment (COVID-19 Economic Response No. 2) Bill 2021 without notice. During his second reading speech the Assistant Treasurer explained that the bill would enable the government to support individuals and businesses impacted by COVID-19 lockdowns. After his speech, the House gave leave for the debate to continue. The Shadow Treasurer was the first speaker and moved a second reading amendment.

During the day, several members spoke in the debate. Just prior to the adjournment of the House, the second reading amendment was disagreed to and the second reading agreed to on the voices. By leave, an assistant minister moved the third reading and the question was carried on the voices.

### 23.02 Amendments moved on behalf of absent members

Over the sitting fortnight, opposition members moved amendments on behalf of members unable to attend sittings due to COVID-19 restrictions. For example, during debate on the Family Assistance Legislation Amendment (Child Care Subsidy) Bill 2021, Dr Andrew Leigh indicated that he was moving a second reading amendment on behalf of the Shadow Minister for Early Childhood Education, Ms Amanda Rishworth. The next day, during consideration in detail of the bill, Dr Leigh moved amendments circulated in the name of the shadow minister. In both cases, the shadow minister spoke in the debate via video link.

*According to the Agreement for members to contribute remotely to parliamentary proceedings, members participating remotely may not move a motion or an amendment.*

On 4 August, the Assistant Treasurer moved Customs Tariff Proposal (No. 4) 2021. He explained that the proposal extended the free rate of customs duty applicable to certain medical and hygiene goods suitable for use in combating COVID-19. Debate was adjourned.

*Tariff proposals take effect once they have been moved. It is not necessary for the motion to be agreed.*

### 23.08 Personal explanation by Leader of the Opposition

On 3 August, the Leader of the Opposition made a personal explanation claiming that the Prime Minister had misrepresented him during question time that day, by incorrectly stating that he had refused a briefing from Lieutenant General Frewen, Coordinator of the National COVID Vaccine Taskforce.

During Question Time on 5 August, on a point of order, the Leader of the Opposition complained that the Prime Minister had repeated the misrepresentation. The Speaker advised that the claim should not be made again unless there was new information. Later that day, the Leader of the Opposition made another personal explanation in relation to the matter.

*Standing order 68 allows the Speaker to intervene where a member has made a personal explanation to correct a misrepresentation and another member subsequently repeats the matter complained of.*

### 23.09 Voting intentions of absent members presented

On 9 August, the Manager of Opposition Business, by leave, presented the voting intentions of Ms Zali Steggall and Mr Andrew Wilkie for the previous sitting week. During members' statements, government member Mr George Christensen made some controversial remarks regarding COVID-19. Later, during question time, the House granted leave for the Leader of the Opposition to move a motion calling on all members to refrain from spreading misinformation in relation to the pandemic. The Prime Minister and another opposition member spoke before the motion was carried on the voices.

## Parliamentary administration

### 23.12 Statement by Speaker regarding COVID-safe arrangements

At the beginning of the sitting fortnight, the Speaker make a statement to inform members of special arrangements put in place at Parliament House in response to COVID-19 outbreaks across the country.

He explained that the building was closed to the public and that access would only be granted to people for essential business. He asked all building occupants to wear a mask whenever possible, including members in the chamber (when not speaking).

He further advised that strict physical distancing requirements would be followed in the Chamber and directed members to sit only in their allocated seats.

### 23.13 Agreement for members to contribute remotely

After the Speaker's statement, a minister presented an *Agreement for members to contribute remotely to parliamentary proceedings* made between the Acting Leader of the House and the Manager of Opposition Business, to apply for the sitting fortnight. This allowed several members unable to attend sittings because of COVID-19 to participate in proceedings via the official video facility. In total, 41 members participated remotely at least once.

### 23.14 Question to Speaker regarding possible changes to quorum requirement

On 12 August, the Manager of Opposition Business asked the Speaker a question regarding the resolution of the House adopted at the beginning of the pandemic, on 23 March 2020, which allowed for the House to meet in a manner and form not provided in the standing orders, with the agreement of the Leader of the House and the Manager of Opposition Business. He noted that, according to the resolution, any changes to the quorum of the House (currently 31 members) would need to be determined by the Speaker and asked the Speaker to clarify how this would work in practice, given the unfolding COVID-19 situation across Australia.

The Speaker responded that, while such action was currently not required, if the House needed to sit with a lower quorum then this would need to be agreed between the Leader of the House and Manager of Opposition Business and authorised by himself as Speaker. At that point, he explained, the House could meet with the lower quorum and relevant documentation would be presented for completeness.
