Bills

27.01 Debate management motion for communications bill

During government business on Wednesday morning, the Deputy Leader of the House moved, on behalf of the Leader of the House and pursuant to notice, a suspension of standing and sessional orders relating to proceedings on the Communications Legislation Amendment (Combatting Misinformation and Disinformation) Bill 2024 to enable it to be debated after the usual time for adjournment. The motion provided that if the second reading debate on the bill had not concluded before the adjournment debate, it would be called on for further consideration at 8 pm, with debate continuing until a division was called, or 10 pm, or a later time specified by a Minister prior to 10 pm, at which time debate would be adjourned and made an order of the day for the next day, and the House immediately adjourned. The motion was agreed to on the voices.

The second reading debate then resumed and continued until it was interrupted at 1.30 pm for members' statements. Later, after the matter of public importance discussion, debate again resumed, continuing until 7.30 pm when it was interrupted for the adjournment debate. At the conclusion of the adjournment debate, in accordance with the resolution, the second reading debate on the bill was again resumed at 8 pm and continued until 10 pm. Debate was adjourned, and the House stood adjourned until the next day.

27.02 Consecutive speeches during consideration in detail

In the Federation Chamber on Wednesday, consideration in detail commenced on the Privacy and Other Legislation Amendment Bill 2024. At a previous meeting of the Federation Chamber on 9 October, when no further members had risen to speak on the second reading of the bill, the second reading had been agreed to and the bill reported to the House without amendment; however, later that day, the bill was re-referred to the Federation Chamber, where the Leader of the House moved, in accordance with standing order 154, that the bill be reconsidered in detail. Further consideration of the bill was then adjourned and not called on again in that sitting week.

On Wednesday, several members who had not been able to speak during the second reading debate in October were allowed to continue speaking for an additional five minutes after their initial five-minute contribution to debate on the question that the bill be agreed to and were afforded some latitude on relevancy during debate. Following these contributions, other members moved detail amendments, thus constraining further debate to the content of each of those amendments.

During consideration in detail, each member may speak for an unlimited number of periods up to five minutes each and may speak again immediately if no other member seeks the call.

27.03 Suspension of standing order 43 to assist passage of bill

On Thursday, the Leader of the House moved, by leave, to suspend standing order 43 to allow all remaining questions on the Aged Care Legislation Amendment Bill 2024 to be moved before the commencement of statements by members. The motion, which was moved following a division on a second reading amendment held shortly after 1.30 pm, was agreed to on the voices. The remaining stages of the bill were then completed and the period for members' statements commenced at 1.38 pm.

Standing order 43(a) provides that the Speaker shall interrupt business and call on statements by members at 1.30pm and that the period for statements may extend until 2 pm – that is, until Question Time.

This memorandum will ensure IPEA's powers are exercised in a way that affords parliamentarians an opportunity to raise claims of parliamentary privilege and will safeguard the relevant information and documents whilst claims of parliamentary privilege are being considered.
