Request for access to documents under Freedom of Information Act 1982

I refer to your email to the Department of Parliamentary Services (DPS) on 11 January 2013, receipt of which was acknowledged on 15 January 2013.

In your email, you requested access under the *Freedom of Information Act 1982* to information about the volume of email received by Senators and Members in the period 2000 to 2012.

The figures below are the annual (financial year) total numbers of all emails transmitted across the internet and within the Parliamentary Computing Network (PCN). The table comprises email traffic relating to all users of the PCN, including Senators and Members and their staff, and all staff of the parliamentary departments. All email in Parliament House (and to electorate offices) is delivered via the aph.gov.au domain name. The data is unable to be broken down into the categories of Senators, Members or their staff.

I note that ministerial email is managed by the Department of Prime Minister and Cabinet.

You may also complain to either the Australian Information Commissioner or the Commonwealth Ombudsman about action taken by the Department in relation to the application.
