Purpose of listing—This listing has been prepared and published specifically to comply with the Senate Order of 20 June 2001, as subsequently amended, on government agency contracts.

Confidentiality and disclosure provisions in contracts—DPS has confidentiality and disclosure provisions for all new contracts to make contractors aware of the policy that contractual documentation may be made available to parliamentary committees, the ANAO etc for reasons of accountability and transparency. Currently and in the future, contractors will be asked to identify specific information in their offers they consider is of a commercially confidential nature and to provide supporting reasons.
