Dear Mr Coulthart

I have your facsimile of Friday afternoon.

In the time available to me, I have not had the opportunity to consult the relevant Senate officers to verify my understanding of the rules so I have separately written today to ask them to check on Monday and take appropriate action.

In the interim, I have checked my own records and consulted my accountant and the details set out here are as I understand them without having the benefit of advice from the Registrar of Senators' Interests.

You are in error regarding the entity cited in your facsimile. W.P. Heffernan Nominees Pty Ltd is wholly owned by my brother.

I should note that via Dew Pastoral Company which is the registered business name for Sestial Pty Ltd as trustee for the Bill Heffernan Family Trust, I control 1089 shares in AWB Ltd. Relevant entities have been disclosed to the Senate.

I am not a share investor or trader. The shares came to me in the same way that other farmers were allocated shares at the time of the restructuring of the wheat industry in 1996. Over the past decade, via that company's dividend reinvestment arrangement, the number of shares has slowly grown to its current level. For example, my most recent, franked credit of \$138.58 was converted to 23 shares at \$5.89 per share.

The total value of this holding would now be \$4094.64 (\$3.76 per share as at 10 March 2006).

You asked whether I have ever met Mr McConville. During my ten years in the Senate, both as a farmer and as someone with an extensive interest in policies relating to rural Australia, I have met various AWB executives. It is possible that I have met Mr McConville at some point but to my recollection and after checking my diary, I did not meet him in the context of his email dated 26 April 2000 relating to Iraq wheat sales.

You also raised the question of any specific knowledge I had about AWB's activities in Iraq. I attach a copy of a Press Release issued on 9 February 2006 (following a recent speech in the Senate and an interview on SBS's DATELINE with George Negus). I stand by that statement.

I find it mystifying that there could be any doubt about my long held views on these matters. For many years, I have been a strong critic of AWB. There is ample evidence to attest to that fact via my work with the Senate Rural and Regional Affairs and Transport Committee (just check the Hansard), numerous media interviews and on occasion in the Senate. Those AWB executives that I have encountered from time to time would not be under any misunderstanding about my views.

Any suggestion that I have been an advocate or apologist for AWB Ltd because of a small shareholding, obtained in common with other farmers, when the wheat industry was restructured a decade ago is just ridiculous.

Earlier this evening ABC TV carried a report linking the issue of alleged Iraq kickbacks by AWB with remarks I made in the Senate this afternoon.

The media report quotes me as saying:

"we have been saying this for three years"

What they did not quote was the next sentence

"The conflict of interest that has existed between the growers' interests and the shareholders' interests has been intolerable"

While I do have a reservation about the capacity of the Wheat Export Authority (WEA), this has focussed on the conflict of interest that I believe has existed between the growers' interests and the shareholders' interests. This has been a long-standing concern.

As I indicated on SBS Dateline last night when asked by George Negus whether I had gone to the Government to warn about a wheat racket:

"I didn't say it was a racket because I didn't know what was going on. I honestly and earnestly - and I get myself into a lot of trouble seeking the truth at times - but I didn't know what was going on. Honestly, if I had have known what was going on, I would have kicked someone's head in."
