Chapter 1

Budget Estimates 2019–20

Reference

1.1 On 2 April 2019, the Senate referred the following to the Senate Finance and Public Administration Legislation Committee (the committee) for examination and report:

Particulars of proposed and certain expenditure for 2019-20

- Particulars of proposed expenditure in respect of the year ending on 30 June 2020;
- Particulars of certain proposed expenditure in respect of the year ending on 30 June 2020; and
- Particulars of proposed expenditure in relation to the parliamentary departments in respect of the year ending on 30 June 2020. 1

Portfolio coverage

- 1.2 The committee has responsibility for examining the expenditure and outcomes of the following departments and agencies:
- Parliament;²
- Prime Minister and Cabinet (PM&C) Portfolio; and
- Finance Portfolio.³
- 1.3 Pursuant to an order of the Senate, the committee also holds a separate hearing on cross-portfolio Indigenous matters.⁴
- 1.4 Departments and agencies under the committee's oversight are listed in Appendix 1 of this report.

Portfolio Budget Statements 2019–20

1.5 The Portfolio Budget Statements (PBS) 2019–20 for the PM&C Portfolio, the Finance Portfolio and the Parliamentary departments were tabled in the Senate on 2 April 2019.⁵

Establishment of a new Executive Agency

1.6 On 1 March 2019, the North Queensland Livestock Industry Recovery Agency was established as an Executive Agency under the *Public Service Act 1999*, and within PM&C portfolio.⁶

Hearings

- 1.7 The committee held public hearings on 4, 8 and 9 April 2019. A multi-portfolio day was held on 4 April 2019 that covered the PM&C and Finance portfolios in addition to the examination of cross-portfolio Indigenous matters.
- 1.8 The Parliamentary departments and departments and agencies in the PM&C Portfolio (excluding Indigenous matters) were examined on 8 April 2019, and agencies and departments in the Finance Portfolio were examined on 9 April 2019.
- 1.9 The committee took evidence from the President of the Senate, Senator the Hon. Scott Ryan, and the following Ministers accompanied by officers of relevant departments and agencies:
- Senator the Hon. Mathias Cormann, Minister representing the Prime Minister, Minister for Finance and the Public Service;
- Senator the Hon. Marise Payne, Minister representing the Minister for Women (on 4 April 2019);
- Senator the Hon. Anne Ruston, Minister representing the Minister for Women (on 8 April 2019);
- Senator the Hon. Zed Seselja, Assistant Minister for Treasury and Finance;

Answers to questions on notice—Additional Budget Estimates 2018–19

The committee's examination of the Additional Budget Estimates 2018–19 took place on 18 February for the Parliamentary departments and the PM&C portfolio, 19 February 2019 for the Finance portfolio and 22 February 2019 for the crossportfolio Indigenous matters. The committee fixed 29 March 2019 as the date for the return of answers to questions on notice.

Timeliness of answers to questions on notice

- The committee had a total of 318 questions taken on notice⁷ with a total of 1.15 152 answers being received by the due date.
- The Finance portfolio did not provide any of its answers to questions on notice from its hearings on 19 February 2019 by the due date of 29 March 2019. All answers were returned on 4 April 2019.
- 1.17 The Department of Parliamentary Services provided 35 out of 43 responses to questions on notice from its hearing on 18 February 2019 by the due date of 29 March 2019. The remaining questions on notice were responded to by 3 April 2019.
- The PM&C Portfolio (including cross-portfolio) provided 111 of its 175 answers to questions on notice from its hearings on 19 and 22 February 2019 by the due date of 29 March 2019. The remaining 64 questions on notice were provided by 8 April 2019. As part of cross-portfolio Indigenous matters, the Department of Health provided 6 of its 12 answers to questions on notice from the hearing on 2 February 2019 by the due date. 5 questions were provided between 1 April 2019 and 9 April 2019. As at 10 April 2019, the Department of Health has 1 question outstanding.
