Chapter 1

Additional estimates 2017–18

- 1.1 On 8 February 2018, the Senate referred the particulars of the proposed 2017–18 additional expenditure to legislation committees for inquiry and report in accordance with the allocation of portfolios to committees.¹
- 1.2 The Senate Community Affairs Legislation Committee (committee) held hearings on 28 February 2018 and 1 March 2018 to consider the proposed additional expenditure of the Health Portfolio, Social Services Portfolio and Human Services Portfolio.²
- 1.3 The Senate resolved that the committee should report with respect to additional estimates 2017–18 on 27 March 2018.³

Portfolio allocation

- 1.4 The committee is responsible for examining the proposed expenditure of the department and agencies within the Health Portfolio, Social Services Portfolio and Human Services Portfolio. The Commonwealth departments within those portfolios are the Department of Health (DOH), Department of Social Services (DSS) and the Department of Human Services (DHS).
- 1.5 The committee notes that in accordance with amendments made to the Administrative Arrangements Order on 20 December 2018:
- DHS is no longer incorporated into the Social Services Portfolio; and
- matters of multicultural policy have been transferred from DHS to the Department of Home Affairs.⁵

Referral of documents

- 1.6 The Senate referred the following documents to the committee with respect to additional estimates 2017–18:

- 1.10 The committee also heard evidence from agencies within the Health Portfolio as listed at Appendix 1.

- 1.12 The committee heard evidence from: the Secretary of DSS Ms Kathryn Campbell CSC; senior officers of DSS; the Chief Executive Officer of the National Disability Insurance Agency (NDIA) Mr Robert De Luca; senior officers of the NDIA; and Senator the Hon. Concetta Fierravanti-Wells, Minister for International Development and the Pacific (representing the Minister for Social Services).

Human Services Portfolio

- Outcome 1: Support individuals, families and communities to achieve greater self-sufficiency; through the delivery of policy advice and high quality accessible social, health and child support services and other payments; and support providers and business through convenient and efficient service delivery.
- 1.13 The committee heard evidence from: the Secretary of DHS Ms Renée Leon PSM; senior officers of DHS; and Minister Fierravanti-Wells (representing the Minister for Human Services).

Procedural matters

- 1.14 During the committee's examination of DHS on 1 March 2018, the Chair sought advice regarding a senator's questions on the involvement of staff in the office of the Hon. Michael Keenan MP, Minister for Human Services, in briefing media prior to an Australian Federal Police raid on the Victorian offices of the Australian Workers' Union on 24 October 2017. Notably, the senator's questions related to periods prior to Minister Keenan's appointment as the Minister for Human Services. Subsequent to receiving advice, the Chair stated that all questions relating to the operation of the Minister's office prior to his appointment as Minister for Human Services were out of order.
- 1.15 During the hearings, comments were made by some witnesses suggesting they were unable to provide answers to senators' questions as the response would include information that was provided as advice to government. The committee reiterates the following advice provided to witnesses in the Chair's opening statements:

[t]he Senate has resolved that there are no areas in connection with the expenditure of public funds where any person has discretion to withhold details or explanations from the parliament or its committees unless the parliament has expressly provided otherwise.⁹

Chapter 2

Issues

2.1 This chapter lists the issues examined by the committee during its additional estimates 2017-18 hearings on 28 February 2018 and 1 March 2018.

Health Portfolio—28 February 2018

Cross Portfolio Outcomes / Corporate Matters

- Availability of training and rotational places for medical graduates in rural locations, with particular reference to the potential establishment of the 'Murray Darling' medical school.²
- Increases in the total levels of expenditure within the Health Portfolio since supplementary budget estimates 2017–18.³
- Advice provided by the Department of Health (DOH) in relation to the government's proposed trial of drug testing welfare recipients in selected locations.⁴
- Aboriginal and Torres Strait Islander people's access to the Medicare Benefits Schedule (MBS) and the Pharmaceutical Benefits Schedule (PBS).⁵
- Australia's adherence with the provisions of the World Health Organisation's Framework Convention on Tobacco Control.⁶
- Particulars of the roll-out of Headspace centres for providing youth mental health services. 7
- Payments made by DOH to the Pharmaceutical Society of Australia to update its standards.⁸

- Briefing provided to government regarding a lottery to fund the NSP and the withdrawal of an offer to brief senators. 10
- Australian Sports Commission's return on investment from Olympic-level sports initiatives. 11
- Matters pertaining to the operation of the Australian Sports Anti-Doping Authority (ASADA), including ASADA's negotiation of a contract with the Gold Coast 2018 Commonwealth Games Corporation to provide anti-doping services. 12

Outcome 4: Individual Health Benefits

Program 4.1: Medical Benefits

- Expenditure, total savings, and reinvestments arising from the MBS review and the effects that revised MBS listed items could have on after-hours care providers. ¹³
- Effectiveness of MBS listed items in relation to abortion services. 14

• Government commissioned reports which made recommendations regarding hearing services, particularly the Translating and Interpreting Service, the supply of hearing technology and the costs associated with potential changes to the Hearing Services Program. ¹⁵

- Factors influencing general practitioners' prescription of Mifepristone for pregnancy termination. ¹⁶
- Pharmaceutical Benefits Advisory Committee's consideration of: removing Primoteston from the PBS; the addition of a high-dose flu vaccine to the National Immunization Program; and approval of a vaccine for the treatment of pertussis.¹⁷

• Benefits of the Life Saving Drugs Program (LSDP) and the increased quantum of drugs listed through the LSDP. ¹⁸

Program 4.4: Private Health Insurance

- Increases to private health insurance (PHI) premiums, particularly in relation to modelling undertaken by DOH of PHI policy options, and trends indicating fewer people consuming PHI products. ¹⁹

Outcome 2: Health Access and Support Services

Program 2.3: Health Workforce

• Issues relating to strengthening of the rural workforce including: the conditions under which a former minister was appointed to a position at Charles Sturt University, proposal for the establishment of the Murray-Darling medical school and an update on work undertaken by the National Rural Health Commissioner.²⁴

Program 2.4: Preventative health and chronic disease support

• Progress made with establishing the National Cervical Screening Program and the functionality of the national database to support the program.²⁵

- Funding model for the National Ice Action Strategy, particularly the allocation of funds to Private Health Networks (PHNs) and the capacity of residential treatment services available through the PHNs. ²⁶
- Funding of health initiatives for the prevention of stillbirths. ²⁷
- Provisions of the Food Standards Code for regulating nano-hydroxyapatite particles in baby formula. 28
- Australia's policy for regulating the herbicide glyphosate.²⁹

Program 2.5: Primary Health and Chronic Disease Support

• Establishment and provisions for the Greater Choice for At Home Palliative Care Measure and other national palliative care initiatives.³⁰

Program 2.7: Hospital Services

- Funding arrangements under the Heads of Agreement between the Commonwealth and the States and Territories on public hospital funding and health reform.³¹
- Commonwealth funding contributions to state hospitals in response to increased demand for hospital services, particularly with respect to hospital funding in Western Australia.³²

Program 2.1: Mental Health

- Factors considered by government regarding the allocation of Headpsace centre locations, and funding arrangements for the mental health services provided by the centres.³³
- Government's announcement for \$110 million of funding for child and youth mental health services and the organisations that received funding as a result of that announcement.³⁴

- Community concern regarding PFAS contamination at RAAF Base Williamstown and the implementation of an epidemiological study undertaken in response to the contamination. 42

Social Services Portfolio—1 March 2018

- Response by the Department of Social Services (DSS) to an instance of an unauthorised person gaining access to DSS' data, which included personal details of staff, through an information and communications technology (ICT) system administered by a DSS' contractor. 44

Outcome 1: Support individuals, families and communities to achieve greater self-sufficiency; through the delivery of policy advice and high quality accessible social, health and child support services and other payments; and support providers and businesses through convenient and efficient service delivery.

- Telephony performance of Centrelink, including high rates of unanswered calls or calls taken with long wait times, and DHS' efforts to better utilise available resources to address telephony problems.⁶⁴
- Changes to average staffing levels in DHS, including the commencement of the recent trial of outsourcing of work to Serco and particulars of the contract that supports the trial.⁶⁵
- Accessibility of correspondence sent by Centrelink to social welfare recipients and Centrelink's review of its correspondence through user acceptance testing processes.⁶⁶
- Centrelink's processes for verifying income information of current and former welfare recipients used to calculate debts raised under the online compliance initiative. ⁶⁷
