## **National Rental Affordability Scheme Tenant Demographic Report**

The National Rental Affordability Scheme (NRAS) is an Australian Government initiative, working in partnership with the states and territories, to stimulate the supply of new affordable rental dwellings.

Approved participants of the Scheme are eligible to receive a national rental incentive for each approved dwellings where it is rented to eligible low and moderate income households at a rate that is at least 20 per cent below the prevailing market rates.

Approved participants provide tenant data annually to assist the Department of Social Services to satisfy the compliance requirements prescribed by the Schemes regulations and to better understand the types of tenants living in NRAS dwellings.

The data published in this report was obtained from NRAS dwellings which were reported as tenanted during the 2015-2016 NRAS year. Some questions asked within this report are optional, with mandatory questions denoted throughout the report.

## Tenant Demographic Data Breakdown on 30 April 2016

All tenant demographic data included in this report is a point in time snap shot as at 30 April 2016, for the 2015-16 NRAS Year. The information provided in the below tables are answers obtained via the tenant consent form required to be lodged for occupied dwellings in the NRAS program.

**Key points** (as at 30 April 2016):

- Total number of NRAS tenants accommodated in the Scheme was **60,704** for a total of 31,078 dwellings. A breakdown of these tenants by State and Territory are shown in Table 1 and by age in Table 3.
- **48,980** tenants responded to voluntary questions about their prior living arrangements as shown in Table 2.
- The Household composition figures in Table 4 include mandatory responses for occupants identifying as either Sole Parents or Independent Minors. These demographics made up **7,908** of the total 101,794 responses received. **Note:** occupants could identify in more than one category.
- An '\*' within the tables below denotes a mandatory response. All other responses are voluntary.
