Homelessness data tables – March 2020

Note 1: The following figures relating to numbers and rates of homeless persons are produced by the Australian Bureau of Statistics (ABS) and are **estimates**, not actual figures.

Under the ABS Census method, a series of analytical techniques based on both the characteristics observed in the Census and assumptions about the way people respond to a Census question are applied to estimate the number of homeless persons.

The approach considers people living in private dwellings and non-private dwellings (e.g. hotels, boarding houses, prisons, hospitals, hostels for the homeless etc.) on Census night, and those who on Census night were in areas where people are known to live in improvised dwellings, tents or to be sleeping out.

Note 2: The interior values in **all tables** have been randomly adjusted (perturbed) by the ABS to ensure confidentiality, and as a result may not add to the totals. See bottom of **Page 6** for a detailed explanation of perturbation and other definitions.

5: Comparative historical data and any modelling conducted on housing and homelessness in Australia over the last 7 years.

Comparative historical data

The department has not conducted any modelling on housing and homelessness in the past seven years.

The ABS publishes 6416.0 - Residential Property Price Indexes: Eight Capital Cities, which indexes the value of residential property in Australia over time.

The Reserve Bank of Australia produces a Household Sector Chart Pack which tracks a number of measures relating to housing and housing affordability over time, including:

- Consumer sentiment
- Private dwelling investment
- Private residential building approvals
- House prices and household debt
- Household wealth and liabilities
- Housing prices, and
- Housing loan commitments

Definitions

Perturbation

Perturbation (randomisation) is applied by the ABS across all non-zero cells in a table, including the totals cells. Perturbation may change the true cell value by either increasing or decreasing the value by a small amount. This introduces almost no bias. However, very small cells may change by a large amount in proportion to the true value, and therefore should not be relied upon. All non-zero cells in tables are subject to perturbation, a small adjustment made to cell values, including totals, to protect the confidentiality of the data.

Totals are not calculated by summing the interior values of the table. Instead, more accurate totals are provided by calculating the true total, and then perturbing this value. Perturbation makes small changes to all estimates including both the interior cells of the table and the totals. If you attempt to reconstruct a total on the basis of the perturbed interior cells, you will add together the small changes made to each cell which may result in a large change relative to the perturbed total.

Housing Stress

The ABS defines households as being in 'housing stress' when they meet the definition of lower income and pay 30 per cent or more of their gross household income to housing costs.

Lower income household

The ABS defines Lower income households as those households containing people with equivalised disposable household income between the 3rd and 40th percentiles, and excluding the 1st and 2nd percentiles.

Place of enumeration

Place of enumeration is the place at which the person is counted i.e. where they spent Census night, which may not be where they usually live.

Place of usual residence

Place of usual residence refers to where a person usually lives regardless of where they were on Census night.

2: Number of homeless persons

Note 1: Table 10 below details the number of homeless persons by ABS homelessness operational groups based on their **place of enumeration** (i.e. where they were counted on Census night). **Tables 1** through **8** in this document are based on **place of usual residence** at the state or territory level.

ABS 2049: Census of Population and Housing, 2016 presents both place of enumeration and place of usual residence counts. The calculation of the homeless rate at the State/Territory and Australia level is based on **usual residence** to allow comparisons with other Census rates (e.g. people with a disability) which are typically calculated on a **usual residence** basis.

However, the homelessness rate at the sub-State level (i.e. SA2, SA3 and SA4 geography) is calculated on a **place of enumeration** basis to help identify areas where services are needed, particularly homeless people who do not have a usual address.

Note 2: The Commonwealth Electoral Division data below (exclusive of state and territory totals) have been provided to the department by the ABS as a customised request, and are not published on the ABS website.

Note 3: The state and territory totals below have been sourced from ABS 2049: Census of Population and Housing, 2016 – Table 5.1. Because electoral boundaries in some cases cross state or territory boundaries (for example Norfolk Island which is geographically separate from the ACT but included in the ACT's electorate of Bean), these totals are not representative of the summed electorate totals.

Note 4: Cells in the below table have been randomly adjusted (perturbed) to avoid the release of confidential data. No reliance should be placed on small cells and interior cells may not sum to totals.
