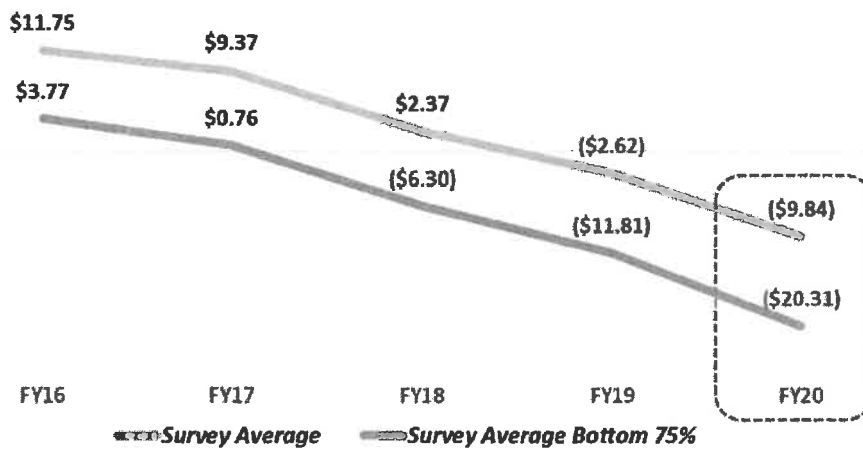

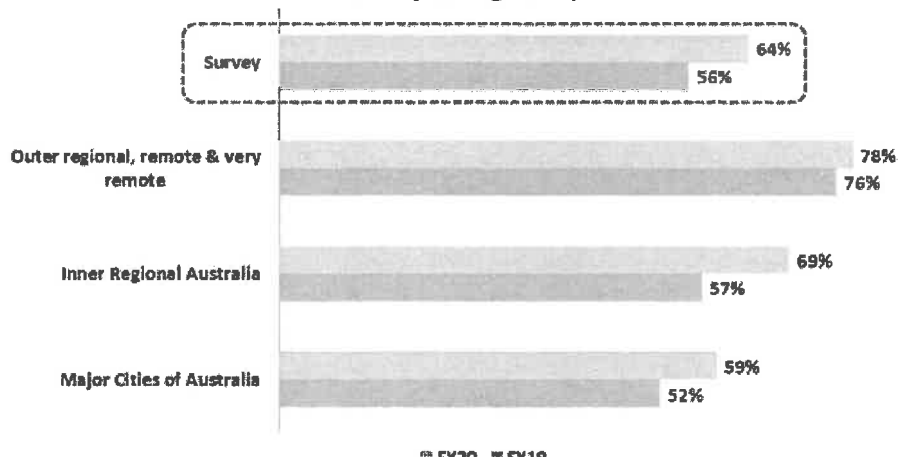
StewartBrown survey findings (leading aged care industry accountants)
