## Support for Trafficked People Program Data for Victims of Forced Marriage

### Forced Marriage Support Stream

The Support for Trafficked People (STPP) was originally developed in 2004 to respond to the needs of survivors of trafficking and slavery offences, who predominantly at that time were women being trafficked for sex. The STPP began receiving referrals for people affected by, or at risk of, forced marriage in 2014, soon after forced marriage was criminalised in Australia.

Under the STPP model, forced marriage clients could receive an initial 45-90 days of support, with further support being contingent on participating in the criminal justice process. In contrast to other clients on the STPP, the alleged perpetrators of forced marriage crimes are often family or community members, and survivors are reluctant to participate in a criminal justice process in these circumstances, particularly when they are young and living in the familyhome.

In 2018, the Australian Government announced a trial for the STPP to allow eligible survivors of forced marriage to access up to 200 days of support without having to participate in a criminal justice process. The Australian Red Cross was provided \$500,000 in 2017-18 to implement and evaluate the Forced Marriage Trial (FM Trial).

In December 2019, the FM Trial was integrated into the STPP on an ongoing basis as the Forced Marriage Support Stream (FMSS).

Clients on the FMSS are not required to participate in a prosecution or law enforcement action, however, are still required to be referred to the STPP by the Australian Federal Police.

The Department of Social Services does not track outcomes for clients once they exit the program. The STPP ensures that clients who have been supported on the FMSS, but have ongoing needs at the time of exit, are referred to other support services as required.

The following tables provide data relevant to the ongoing FMSS component of the STPP, in accordance with the request made through SQ19-000367.

Tables 1, 2 and 3 respond to QoN question 3, relating to the number of forced marriage victims supported on and referred to the STPP, and number of clients supported on the FMSS.
