Notes for Tables 1 to 5

- From December 2022, Services Australia implemented a change in the Centrelink payment system to recognise gender other than the sex assigned at birth or during infancy, or as a gender which is not exclusively male or female. To protect the privacy of individuals and comply with confidentialisation policy, persons identifying as 'non-binary' will initially be grouped with 'females' in the period immediately following implementation of this change. The Department of Social Services will monitor the implications of this change and will publish the 'non-binary' gender category as soon as privacy and confidentialisation considerations allow.
- Indigenous recipients include only those who have voluntarily identified as Indigenous for program purposes. This data may therefore represent an undercount.
- Where a number is less than 5 this is indicated by '<5'. To prevent these numbers from being reverse engineered some other numbers are not published (indicated by 'n.p').
- 'Suspension triggered applied' refers to job seekers who do not re-engage within 2 business days of the non-compliance event occurring and the suspension transaction being sent to Services Australia, resulting in a subsequent suspension.
- 'Suspension not triggered' refers to job seekers who re-engage with their provider within 2 business
 days of the non-compliance event occurring. Under old rules, these would have resulted in
 suspension.
