Response to Question on Notice from Senator Carr concerning the DIIS FOI Disclosure Log

1 June 2018

The table in the attached schedule sets out documents released (in full or in part) by the Department of Industry, Innovation and Science (DIIS) in response to requests made under the *Freedom of Information Act 1982* (FOI Act) from 1 July 2017 to 31 May 2018 inclusive.

Some information has been removed from the titles of the documents to prevent disclosure of sensitive information which is exempt from publication on the DIIS FOI Disclosure Log under s 11C(1) of the FOI Act.

In the 1 July 2017 to 31 May 2018 period, DIIS released <u>78</u> documents, <u>5</u> of which should have been posted to the DIIS FOI Disclosure Log but were not. That error has been rectified, and the 5 documents in question are now available on the DIIS FOI Disclosure Log (grouped into 3 entries corresponding to the relevant applications).

The remaining 73 documents were not posted to the DIIS FOI Disclosure Log on the basis that they are exempt from disclosure under s 11C(1) of the FOI Act.
