## Dear's 22 and s 22

We have resubmitted the recommendation on Continuation 621 with a new Ministerial Brief this afternoon as requested.

I wanted to provide some clarity regarding what could occur if the current measures are allowed to expire that may assist the Minister:

- Interested parties could seek merits review of the decision by application to the Anti-Dumping Review Panel or judicial review by application to the Federal Court.
- Interested parties could also make an application for the imposition of new measures.
  - This application would not be limited to the scope/nature of the current measures i.e. it could capture imports by TSP and/or subsidies.
  - This application could be made anytime once the measures have expired and would not require Ministerial approval.
  - o The Commissioner would consider any application and initiate a new investigation if the application is properly constituted, contains sufficient support by the Australian Industry who produce like goods, and there appear to be reasonable grounds for the publication of a dumping duty notice/countervailing duty notice.
