- . Developed positive, enduring relationships with Indigenous communities at each of the school sites proposed for commencement in the short-term and commenced this process with a further community in which a Studio School is likely to be developed in the medium-term
- . Conducted significant engagement with Federal, State and Territory governments to advocate for the creation of a new system of Studio Schools
- . Completed a successful Indigenous Advancement Strategy Grant to support the development of the Business Case and Business and Operational Plans
- . Developed a comprehensive Business Case and Business and Operational Plans for the proposed new system of Studio Schools
- . Engaged (and continue to engage) across corporate

Australia to support philanthropic fundraising and industry engagement with SSA in anticipation of working with corporate Australia to collectively break the cycle of failure in Indigenous education
