Dear Ms Beverly,

I wish to correct my evidence to the 2020-21 Additional Estimates hearing of the Senate Foreign Affairs, Defence and Trade Legislation Committee on 24 March 2021. Relevantly, I wish to correct both the Letter of Correction that I provided to the Committee on 11 May 2021 and the Department's response to tabled Question on Notice 236.

The total number of security incidents stated in my Letter of Correction for evidence I provided both at the hearing and in response to tabled Question on Notice 236 was incorrect. This was due to a transcription error relating to one incident. I subsequently directed an independent review of the Defence security incident database and have confidence that the revised number of security incidents is definitive and can be relied upon by the Parliament.

In response to a question during the hearing from Senator the Hon Penny Wong (page 22 of the Hansard), I stated:

"The third question was about the number of breaches in ministerial offices in that calendar year. There was one incident reported in calendar year 2019, and it was this incident."

I wish to correct my evidence in the Hansard to the following:

"In calendar year 2019, there were six breaches across all ministerial offices in the Defence portfolio reported to Defence."

The error in the number of security incidents was carried through, in part, to the tabled response to Question on Notice 236 (Senator the Hon Penny Wong). In response to this question, I wish to correct paragraph two and add a new paragraph three. The revised response to the question in full is:

1. From 2 March 2019 to 31 December 2020 there have been 12 breaches across all ministerial offices.

- 2. The statement by Ms Katherine Jones "The third question was about the number of breaches in ministerial offices in that calendar year. There was one incident reported in calendar year 2019, and it was this incident" was incorrect and should have stated, "In calendar year 2019, there were six breaches across all ministerial offices in the Defence portfolio reported to Defence."
- 3. For calendar year 2020, there have been eight breaches across all ministerial offices in the Defence portfolio.
