Chapter 1

Additional Estimates 2021-22

- 1.1 On 11 May 2021, the Senate referred the following to the Senate Finance and Public Administration Legislation Committee (the committee) for examination and report:
- Particulars of proposed expenditure in respect of the year ending on 30 June 2022;

- 1.2 The committee has responsibility for examining the expenditure and outcomes of the following departments and agencies:

 - Prime Minister and Cabinet (PM&C) portfolio;
 - Finance portfolio; and
 - cross-portfolio on Indigenous matters.³
- 1.3 Departments and agencies under the committee's oversight are listed in Appendix 1 of this report.

Portfolio Budget Statements 2021-22

- 1.4 The Portfolio Budget Statements (PBS) 2021-22 for the PM&C portfolio, the Finance portfolio and the Parliamentary departments were tabled in the Senate on 11 May 2021.⁴

- 1.15 The Parliamentary departments took nine questions on notice and all answers were provided by the due date.
- 1.16 The Finance portfolio took 100 questions on notice and 45 were provided by the due date, with the 55 remaining responses provided by 11 February 2022.
- 1.17 The Department of Health took four questions on notice. As at the time of this report all four questions remain outstanding.
- 1.18 The PM&C portfolio (including the cross portfolio on Indigenous matters) took 392 questions on notice, with 170 answers provided by the due date. As at the time of this report, 38 answers remain outstanding.

- 1.19 The committee also notes that the PM&C portfolio has 32 answers to question on notice from Budget Estimates 2021-22 (due 16 July 2021) and 60 questions on notice outstanding from Additional Estimates 2020-21 (due 7 May 2021).
- 1.20 The committee highlights its preference for outstanding responses to be provided before the next estimates round.
