Senator Roberts asked Dr Gordon about money spent by NIAA on the referendum.

The NIAA was funded a total of \$23.5 million. This comprised:

- \$11.5 million for a civics education program
- \$12 million for NIAA resourcing including support for the three advisory groups.

Senator Roberts asked Ms Jackson about expenditure, over the last 8 years, on companies that provide contract services. The NIAA was established on 1 July 2019. The below table outlines the expenditure and associated details for the period 1 July 2019 to 31 May 2024:

Senator Cox asked Ms Guivarra and Mr O'Sullivan about First Nations Prison to Employment Program. The NIAA confirms that we will take the questions on notice about this matter and re-direct to the Department of Employment and Workplace Relations who is responsible for this program and can provide responses.

Senator Liddle asked Ms Broun and Ms Jackson about the NIAA's compliance with the Child Safety Framework. NIAA takes child safety seriously, both our work as an Agency and the work we fund. As a Commonwealth entity, the NIAA must publish a statement of compliance with the Framework each year. The NIAA is compliant with the Framework, reported annually in line with the Framework on the NIAA's website at https://www.niaa.gov.au/resource-centre/annual-statement-compliance-commonwealth-child-safe-framework-2023. The most recent statement was published on 26 October 2023.

This Statement of Compliance is supported by the Agency's Working with Vulnerable People (WWVP) policy, which complies with the four requirements of the Commonwealth Child Safe Framework.

In addition, Service Providers must complete a mandatory annual Statement of Compliance to confirm compliance with their obligations for working with children and vulnerable people, which is included in funding agreements. Organisations who do not provide a statement of compliance are subject to sanctions, including withholding of payments and termination of their agreements. Further, the NIAA's site visit checklist also requires staff to check for evidence of compliance with Working with Vulnerable People Including Children and Work Health and Safety obligations. The NIAA's proactive compliance review program includes examination of provider compliance with WWVP (or equivalent) requirements.
