There is no mention of coercive control in a cultural context—and I'm not talking about collective society ways of being or respectful cultural ways of being. There is no mention of things like humbugging, jealousy, cursing or singing; they are really debilitating aspects of coercive control that sit within Aboriginal communities, but there is no mention of those things. We've got a significant issue in Central Australia where we had the alcohol restrictions lifted and then reinstated, with the chaos that caused. Then we had the CDC removed, and the chaos that contributed right across Australia. We've also got a cost-of-living crisis, and people fighting over scarce resources. All those ingredients are significant precursors to an escalation of coercive control—which is very dangerous, along with all the other dangerous areas of domestic and family violence. Within the funding you've got, are there any specific areas to which funding is allocated based on understanding what's happened in terms of the level of coercive control in Central Australia, with those ingredients thrown together? What are you funding that's going to directly deal with the consequences of that under the banner of domestic and family violence?
