

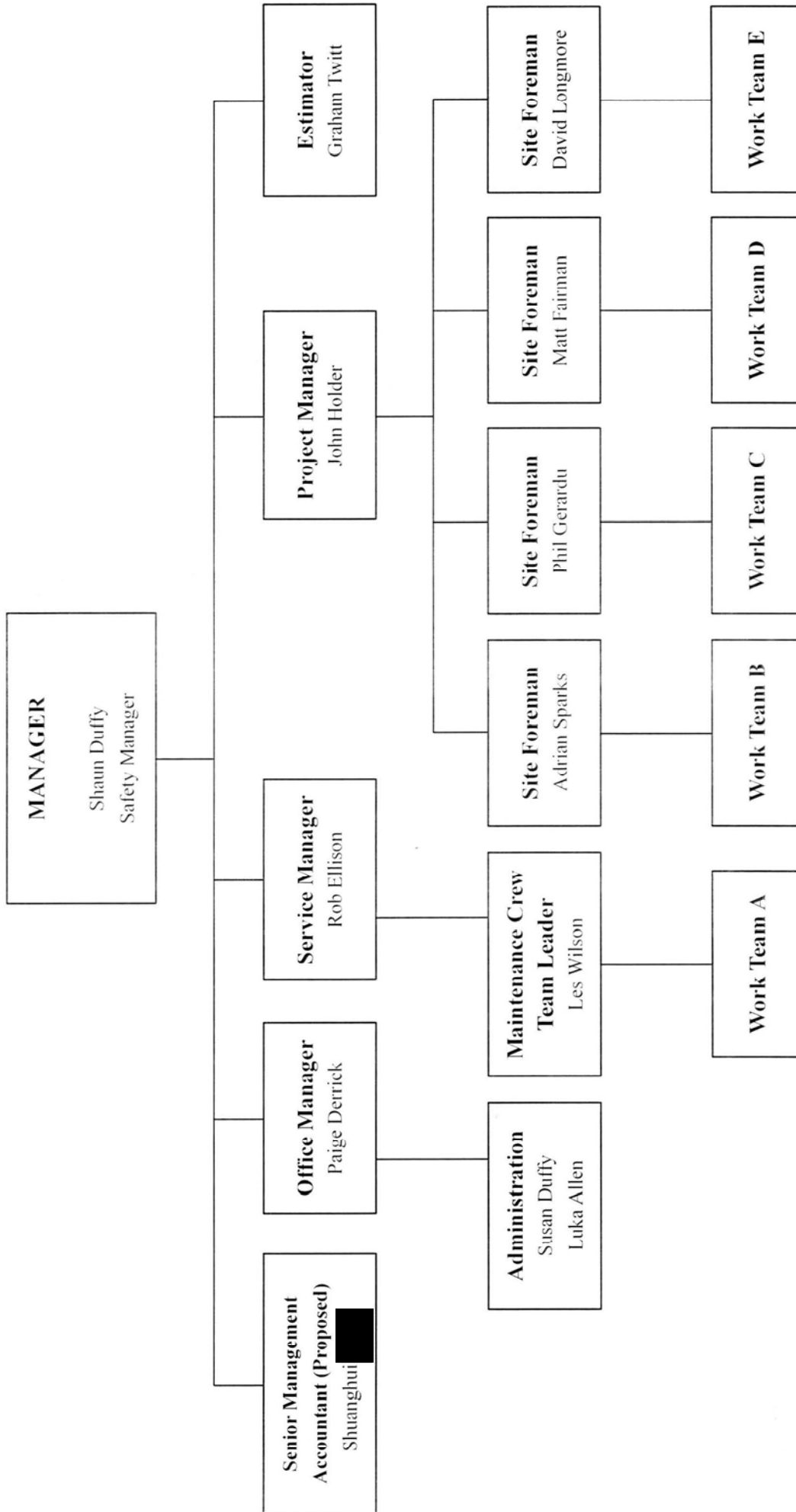

Findings:

Thoracic symmetry, enlargement of left thyroid, anomaly calcified shade inside. The lung window indicates enlargement of hilum of right lung, and irregular high density masses. The bronchus lumen on the right middle lobe is narrowed and patchy ground-glass opacity can be seen, with blur edges and various densities. Fibrous stripes and patchy lesions with blur edges can be seen on the superior segments of left upper lob. Mediastinal window shows that the bronchus lumen on the right middle lobe is narrowed and multiple enlarged lymph nodes on the mediastina. No visible liquidity opacity in both thoracic cavities. The heart shadow and the macro vessels are normal.

Conclusion:

1. Right hilar space-occupying lesions.
2. Atelectasis on the right middle lobe.
3. Infectious Disease on the left upper lobe.
4. Enlarged thyroid gland on the left.
5. Enlarged lymph nodes on the mediastina.
