SENATE QUESTION

(Question No. 943)

Senator Nita Green asked the Minister representing the Minister for Home Affairs, upon notice, on 12 October 2022:

Please provide the following information:

- a. how much the Commonwealth paid in total for the provision of garrison support and welfare services on Nauru between 1 November 2017 and 31 May 2022;
- b. the name of each entity that provided Garrison Support and Welfare Services on Nauru between 1 November 2017 and 31 May 2022, what services they provided, over what period they provided those services and how much they were paid to provide the services; and
- c. the AusTender reference number[s] for any relevant contract[s] under which Garrison or Welfare Services were provided on Nauru over the relevant period.

Senator Watt- The Minister for Home Affairs has provided the following answer to the honourable senator's question:

a. The total administered operating expense for the provision of garrison support and welfare services on Nauru between 1 November 2017 and 31 May 2022 was \$2,317.7 million.
