

Senate Environment and Communications Legislation Committee Additional Estimates 2024-25 Monday, 24 February 2025 Daily summary

The committee met from 9.01am until 10.22pm.

The committee called the Department of Climate Change, Energy, the Environment and Water portfolio, discussing the following topics:

Corporate matters and general questions

- Staffing costs and shared services costs;
- Al use and assurance policies;
- Environmental Defender's Office annual report, financial statements and deed of agreement with the department; and
- Norton Rose Fulbright audit of the Environmental Defender's Office.
