

Senate Environment and Communications Legislation Committee Additional Estimates 2024-25 Tuesday, 25 February 2025 Daily summary

The committee met from 9.00am until 10.25pm.

The committee called the Communication and the Arts portfolio, discussing the following topics:

Program 5.1—Communications and media policy

- Content quotas for streaming services;
- Broadcasting Resilience Program;
- The recently announced Universal Outdoor Mobile Obligation;
- Low Earth Orbit (LEO) satellites;
- Foreign interference in telecommunications;
- News Media Bargaining Code;
- Regional communications funding programs;
- Gambling advertising reform;
- Social media ban for children under 16 years of age;
- First Nations digital inclusion Closing the Gap Target 17; and
- Communications Legislation Amendment (Combatting Misinformation and Disinformation) Bill 2024.

Australian Communications and Media Authority

- Investigation into the Kyle and Jackie O show;
- Australian Code of Practice on Disinformation and Misinformation;
- Revocation of registrations under the News Media Bargaining Code;
- Proposed new protections for telco consumers affected by domestic, family and sexual violence;
- Complaints regarding the shutdown of the 3G network;
- Engagement with the telcos before ACMA publishes press releases; and
- Negotiations with Optus on its fine for committing public safety breaches.

- Members of Parliament's historical attempts to change Chief Executive Officer decisions regarding post office closures.

NBN Co Limited

- Advertising undertaken by the NBN and related expenditure;
- NBN's relationship with Cricket Australia;
- Broadband access for small businesses in rural areas;
- Improvements to the speeds of Skymuster;
- Resilience of the NBN in the face of natural disasters; and
- Operating costs of the NBN.

- Historical funding cuts to Creative Australia
- How Creative Australia deals with conflicts of interest in evaluating the work of applicants.
