

# Senate Finance and Public Administration Legislation Committee Additional Estimates 2024–25 Tuesday, 25 February 2025 Daily summary

The committee met from 9.00am until 11.02pm.

The committee called the Department of the Prime Minister and Cabinet portfolio and the Department of Finance portfolio, discussing the following topics:

## Office of the Official Secretary to the Governor-General

- Update on students injured at Government House;
- The Governor-General's patronage of charities and other community organisations; and
- Australian honours and awards system, removal of awards for perpetrators of child sexual abuse.

## Prime Minister and Cabinet (Office for Women)
