**COMMUNITY CONSULTATION REPORT FOR THE JP154 PHASE 1 COUNTER  
IMPROVISED EXPLOSIVE DEVICE CAPABILITY**

1. This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) about the nature and extent of community consultations undertaken as part of JP154 Phase 1 Counter Improvised Explosive Device Capability Project (Project).

2. In general, no significant issues have been identified throughout Defence's comprehensive and widespread community consultations that will impact on the proposed works, apart from Aboriginal anthropological and heritage issues in Nurrungar, South Australia. However, Defence is satisfied that strategies have been developed that will provide appropriate mitigation.

3. There are 13 project elements that make up the scope of works, broken into two distinct stages as follows:

- a. **Stage 1.** The proposed works under Stage 1 will be delivered at Nurrungar South Australia, and incorporate a test track and support facilities as part of the Counter Improvised Explosive Device Capability.
- b. **Stage 2.** Includes support facilities for the Counter Improvised Explosive Device Capability at the following locations:
  - (1) Defence Science and Technology Organisation and Joint Electronic Warfare Operational Support Unit, Edinburgh, South Australia;
  - (2) Defence Force School of Signals, Watsonia, Victoria;
  - (3) Combined Arms Training Centre, Puckapunyal, Victoria;
  - (4) Army Logistics Training Centre, Bandiana, Victoria;

- (5) School of Military Engineering, Holsworthy, New South Wales;
- (6) Special Operations Engineer Regiment, Holsworthy, New South Wales;
- (7) School of Infantry, Singleton, New South Wales;
- (8) 1<sup>st</sup> Brigade, Darwin, Northern Territory;
- (9) 3<sup>rd</sup> Brigade and Combat Training Centre, Townsville, Queensland;
- (10) 7<sup>th</sup> Brigade, Enoggera, Queensland;
- (11) Special Air Service Regiment, Swanbourne, Western Australia; and
- (12) Joint Logistics Unit-(East), Moorebank, New South Wales.

4. Broadly, the strategy for community consultation adopted by Defence was undertaken with the objectives of:

- a. ensuring that the community was informed about the project using effective, proven communication channels; and
- b. ensuring the community had every opportunity to raise issues of concern so that wherever feasible, they could be addressed by Defence in its program of works.

5. Five main activities were undertaken under the Project consultation plan, namely:

- a. stakeholder briefings (listed in Annex A);
- b. letterbox drop to all residents of Woomera in South Australia, and immediate surrounding area;
- c. communications with local, state and federal political representative (see Annex B);
- d. targeted consultation with the Bungarla and Kokotha Unwankara Aboriginal groups in South Australia; and
- e. provision of a project specific email address to receive community feedback, [jp154@aurecongroup.com](mailto:jp154@aurecongroup.com)

6. Comments and feedback have been overwhelmingly supportive of the Project, with the only significant issue being significant anthropological and Aboriginal heritage at the location for the proposed works at Nurrungar, South Australia. Engagement with the Aboriginal traditional owners has included four years of consultation, with Defence making every effort to be inclusive by:


- a. attending community meetings to present the need and reasons for the project, as well as providing Aboriginal groups updates with respect to the project




- b. working with Aboriginal groups and conducting several surveys to determine the most suitable location for the proposed works to minimise impacts on culturally sensitive locations; and
- c. developing an Aboriginal Heritage Protection Plan, which provides project specific management for Aboriginal anthropology and heritage.

7. Defence is satisfied that it has taken all reasonable steps to inform the community about the project and to provide opportunities to raise any concerns they may have.
