**COMMUNITY CONSULTATION REPORT - GROWLER AIRBORNE ELECTRONIC
ATTACK CAPABILITY FACILITIES PROJECT, VARIOUS LOCATIONS**

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultation undertaken as part of the Growler Airborne Electronic Attack Capability Facilities Project (the Project).

Broadly, the objectives of the strategy for community consultation adopted by Defence were to:

- Ensure that the public was informed about the project using cost effective, wide ranging communication channels; and
- Ensure that the public had every opportunity to raise issues of concern or seek further information.

The consultation activities undertaken included:


- Individual and group information provided through existing relationships with the neighbouring property owners and managers;
- Detailed email correspondence with local groups, State and Federal members with individual briefings conducted where requested. The members and groups consulted, with a short description of the outcomes of the contact, are detailed in Annex A. An example of the correspondence sent to the respective groups is detailed at Annex B;
- Advertisements in the local newspapers, listed in Annex C;
- Community Information Forum and Barbeque Information Evening, details listed at Annex D; and
- Promotion of the Project through local community networks including the QLD Department of State Development, Queensland Government, the RAAF Base Amberley Consultative Working Group, the Katherine Town Council and the Katherine Regional Economic Development Committee.

Key questions and issues raised by the Community through the Community Information Forums are listed at Annex E.

In general, the community feedback regarding the Project was positive. There was good support from the local communities as the Project has the potential to generate employment for local businesses.

In conclusion, no significant issues have been identified during Defence's community consultations that will impact on the proposed works. Defence is satisfied that it has taken all reasonable steps to inform the Community about the project and to provide opportunities for the Community to raise concerns.

Dear

I am writing to you on behalf of The Department of Defence regarding RAAF Base Amberley and Growler Airborne Electronic Attack Capability Facilities Project.

The Growler Airborne Electronic Attack Capability Facilities Project will provide fit for purpose facilities to support and sustain the operation of the EA-18G Growler capability.

The Project will also support the safe employment of the new Growler – Mobile Threat Training Emitter Systems at the Army Aviation Centre Oakey, Queensland and the Delamere Air Weapons Range in the Northern Territory.

The Project will provide new or upgraded working and living accommodation, administration, logistics, and maintenance facilities, training and simulator facilities, multi-storey car park and associated support services and infrastructure.

The estimated cost of the Project is \$348 million, excluding Goods and Services Tax.

Subject to Parliamentary approval of the Project, construction is expected to begin in the first half of 2016 with Initial Operating Capability facilities completed by early 2018 and Final Operating Capability facilities completed by 2021.

COMMUNITY CONSULTATION FOR THE GROWLER AIRBORNE ELECTRONIC ATTACK FACILITIES PROJECT

IPSWICH CONSULTATION

A Community Information Forum was conducted over a period of approximately one hour to allow members of the public to understand the Project and the proposed works. The Community Information Forum was conducted at the following location and time:

- A drop in Community Information Forum was held on Wednesday 07 October 2015 between 6pm and 7pm, at the Ipswich Civic Centre, Lockyer Room. The Session was advertised in the Courier Mail, Toowoomba Chronicle and Queensland Times and through industry groups.
- A total of Twenty Three (23) members of the public attended the evening which included members of the local community, contractors from Brisbane, Ipswich and Gatton as well as a representative from the Queensland State Government.

KATHERINE CONSULTATION

Two Community Information Sessions were conducted to allow members of the public to understand the Project and the proposed works. Community Information Sessions were conducted at the following locations and times:

- The Delamere Range staff hosted a **Barbecue and Information Evening** on the 14th May at the Delamere Range. Managers and owners of all neighbouring stations were invited. Willeroo Station manager and East Matheson Station owner attended. The concerns that were raised at this information session were primarily operational issues regarding the use of aircraft flares and the subsequent bushfires that have affected some of their properties.
- The second concern that was raised was from Jay Mohr-Bell, the owner of East Matheson Station who noted the lack of a northern boundary fence which was reducing his ability to use some grazing areas. Defence's Estate and Infrastructure Group has since supported Mr Mohr-Bell with funding to complete fencing works in accordance with recognised NT property fencing requirements.
- A **Community Information Forum** was held on 14th October at the Katherine Civic Centre. The Session was advertised in the Katherine Times and NT news and through industry groups.
- A total of twenty five (25) people attended the Forum, representing the local community, contractors, industry participation group and local Council Officials. Information was made available that explained the reasons for the project, the scope

of works, and the planned construction program. A number of issues were raised, and are detailed in Annex E.
