**COMMUNITY CONSULTATION REPORT FOR THE EXPLOSIVE ORDNANCE  
LOGISTICS REFORM PROGRAM (EOLRP) PROJECT, MULTIPLE SITES**

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultation undertaken as part of the Explosive Ordnance Logistics Reform Program (the Project).

The objectives of the community consultation undertaken by Defence were to ensure that the community:

- a. was well informed about the Project, by using effective and proven communication channels to convey details of the proposed works; and
- b. had every opportunity to raise issues of concern or seek further information so that, wherever feasible, these could be addressed by Defence.

Multiple activities were undertaken in accordance with the project's Stakeholder and Community Consultation Plan:

- a. Advertisements appeared in local newspapers, including the Muswellbrook Chronicle (Muswellbrook) between 07 and 14 July 2017, the Hunter Valley News (Denman) between 12 and 19 July 2017, and the Magnet (Eden) between 13 and 20 July 2017. Copies of the adverts are at annex A;
- b. Project letters were distributed via post to those residents and businesses residing along Argent Road, Penfield, South Australia, to inform of the increased traffic during construction at EO Depot Edinburgh (a copy is provided at annex B);
- c. Invitations to receive a personal briefing were emailed and posted to key stakeholders; including Federal, State and Territory Members of Parliament, local councils, State and Territory departments and authorities, and community groups. A list of stakeholders and the status of each briefing is at annex C, and examples of the standard invitation letter is at annex D; and

- d. Public Information Sessions were undertaken outside of the local Post Office in Denman (EO Depot Myambat) and in Eden (EO Depot Twofold Bay) on Thursday 20 July 2017 between 11:00am and 2:00pm. Details on the community's attendance at these sessions are at annex E.

Generally, the feedback received from those consulted has been positive and supportive of the proposed works, with no significant issues identified or concerns raised. The communities understood the need for the proposed works and appreciated Defence's approach to both developing the works to minimise impacts as far as practicable, and consulting with them. A table summarising the issues and questions raised by those consulted to date, and how these have been addressed by Defence, is at annex F.

In conclusion, no issues have been identified during Defence's community consultation that will impact the proposed works. Defence is satisfied that it has taken all reasonable steps to inform the community about the proposal and to provide opportunities for the community to raise concerns and questions.

### **EXPLOSIVE ORDNANCE LOGISTIC REFORM PROGRAM PROJECT: WORKS PROPOSED AT EXPLOSIVE ORDNANCE DEPOT EDINBURGH**

On behalf of the Department of Defence, I would like to inform you of works proposed at Explosive Ordnance (EO) Depot Edinburgh under Project J0056 *Explosive Ordnance Logistic Reform Program (EOLRP)*. These works are subject to Parliamentary approval.

EO Depot Edinburgh is located within RAAF Base Edinburgh and the proposed works include the construction of an administration building, EO storage and handling buildings, and associated road and trunk infrastructure upgrades. If approved, works will commence in early 2018.

The project has been referred to the Parliamentary Standing Committee on Public Works (PWC). The full Statement of Evidence can be viewed on the PWC's website at the following address:
