COMMUNITY CONSULTATION REPORT – ENGINE TEST CELL 1 UPRGRADE PROJECT, RAAF BASE AMBERLEY, QUEENSLAND

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultation undertaken as part of the proposed Engine Test Cell 1 Upgrade Project (the Project).

The objectives of the community consultation undertaken by Defence were to ensure that the community:

- a. was well informed about the Project by using effective and proven communication channels to convey details of the proposed works; and
- b. had every opportunity to raise issues of concern or seek further information so that wherever feasible, they could be addressed by Defence in its program of works.

Multiple activities were undertaken in accordance with the Project's Stakeholder and Community Consultation Plan, namely:

- a. Correspondence sent by email to local groups, State and Federal members with the offer of individual briefings upon request. A list of the members and groups consulted is at Annex A, with a short description of the outcomes of the consultation. An example of the correspondence and accompanying Fact Sheet sent from 4 December 2017 to the members and respective groups is provided at Annex B and Annex C respectively.
- b. Advertisements promoting the single Public Information Session were placed in local newspapers from Thursday 30 November 2017 until Thursday 7 December 2017. Publications included the Ipswich Advertiser and The Queensland Times. An example advertisement is provided at Annex D.
- c. One Public Information Session was held on 7 December 2017 at the Ipswich Civic Centre as summarised by Annex E, including matters raised by attendees.

- d. A sample of the displays used at the Public Information Session is provided at Annex F.
- e. The Amberley Consultative Working Group (ACWG) was briefed by the RAAF Base Amberley Base Support Manager (BSM) when it met on 14 November 2017. The ACWG meets quarterly and is chaired by the Air Base Executive Officer and attended by Base representatives, State and Local Government representatives, representatives from community organisations and neighbouring residents.
- f. A web page was created on the Department of Defence's website regarding the Project at www.defence.gov.au/id/etc1; it was viewed 167 times between 4 December 2017 and 10 January 2018. This web page provided information regarding the project itself as well as information about the Public Information Session to promote attendance and inquiries. A sample of the website content is provided at Annex G.

Although limited, feedback received was both positive and neutral; this included incidental media reporting such as that shown at Annex H. The community were interested in noise, vibration and employment opportunities. It was expected that traffic impacts would be raised as an issue of concern, but this did not eventuate. Defence agreed to consider ground vibration measurement due to engine testing and to communicate actions and outcomes relating to this matter through the ACWG.

Defence is satisfied that it has taken all reasonable steps using a variety of methods to inform the Community about the Project and to provide opportunities for the Community to raise concerns and questions.

I am writing to you on behalf of the Department of Defence regarding the proposed upgrade of an existing facility at RAAF Base Amberley.

Amberley is home to a specialist facility that tests the aircraft engines of RAAF's F/A-18F Super Hornet and E/A-18G Growler fleet. The Engine Test Cell 1 (ETC1) Upgrade project will modify the existing facility to be capable of testing F-35 Lightning II aircraft engines while retaining the capability to test Super Hornet and Growler aircraft engines.

FACT SHEET Engine Test Cell 1 (ETC1) Upgrade Project

Background

- The F-35 Lightning II Joint Strike Fighter (JSF) Program is currently the largest defence program in the world. Led by the United States it is a cooperative program with a membership of nine partners worldwide including Australia.
- The Australian F-35A Project is introducing a fifth generation air combat capability to meet Australia's future air combat and strike needs beyond 2030.
- The Australian F-35 Project is delivering 72 F-35A aircraft as well as facilities, weapons and new support systems to meet the fifth generation capability requirements. The F-35A capability will transform the way Air Force and Defence will operate in the future.
- There will be three operational F-35A squadrons; two at RAAF Base Williamtown, NSW and one at RAAF Base Tindal, NT; and a training squadron at RAAF Base Williamtown.
- The worldwide F-35 fleet will be supported by the F-35 Global Support Solution providing logistics support to F-35 operators to increase capability, availability and affordability through economies of scale, interoperability and international cooperation.
- Australia has been assigned the F-35 engine maintenance, repair, overhaul and upgrade responsibility for the Asia Pacific Region. Engine testing is part of this role. Australia will service a regional volume of F-35 engines as part of the Global Support System.

What is the ETC1 Upgrade Project?

- The ETC1 Project involves the upgrade of the existing ETC1 facility to enable testing of an uninstalled F-35 engine, while retaining the ability to test the Super Hornet and Growler engines. This requires a restructure of the facility.
- Subject to Parliamentary approval, ETC1 Upgrade construction is proposed to begin in second-quarter of 2018 and conclude by fourth-quarter 2019.
- The ETC1 Upgrade Project represents a \$23.7 million investment in Defence capability.

Community benefits

- During the construction period, up to 120 personnel will be employed in construction and fit-out activities.
- The Project Manager will aim to maximise opportunities for local industry participation in order to provide a positive economic impact for the region.
- This project will help ensure Amberley's long-term role as a venue for military jet engine maintenance, delivering long term economic benefits to the South-East Queensland economy.

Environmental considerations

- The ETC1 Project is expected to have minimal impact on the community during construction as it is well within RAAF Base Amberley's boundaries and will only involve upgrades to an existing building.
- Traffic impacts on the local community are expected to be minimal. A specific Traffic Management Plan will be developed by the Construction Contractor and access to the site will be from the Contractor Gate on Hansens Road to minimise disruption.
- Noise from engine test operations within the upgraded ETC1 facility is expected to have minimal impact on the community. The upgrade to the facility includes acoustic treatments that will ensure noise from the operation of the facility will have less impact on the community than the base's daily jet movements.
- The Project is not expected to have any impact on Indigenous or non-Indigenous cultural heritage values.
- The removal and disposal of any hazardous materials will be undertaken in accordance with the relevant health and safety guidelines by an appropriately licenced operator.

Next steps


- All infrastructure projects worth in excess of \$15 million are subject to approval by the Federal Parliament after review by the Parliamentary Standing Committee on Public Works (PWC).
- Defence is committed to ensuring that the views of the local community and other stakeholders are considered. An important part of this process is ensuring the community has an opportunity to provide submissions regarding the project.

PUBLIC INFORMATION SESSION

A single Public Information Session was held on Thursday, 7 December 2017, at the Ipswich Civic Centre, over a three-hour period starting at 4:30pm. The Public Information Session was attended by 12 people and this was in line with Project expectations considering that the proposed works are within the Base and of a far smaller magnitude than separate works already underway at the Base.

Project personnel plus the RAAF Base Amberley Base Support Manager were on hand at the sessions to answer questions. The Fact Sheet already emailed to targeted stakeholders was available as a take-away for those who attended to ensure consistent messaging.

The room was configured with a series of display boards that talked to key project areas. The display boards explained the project, provided information around environmental considerations and the next steps in the approval process.

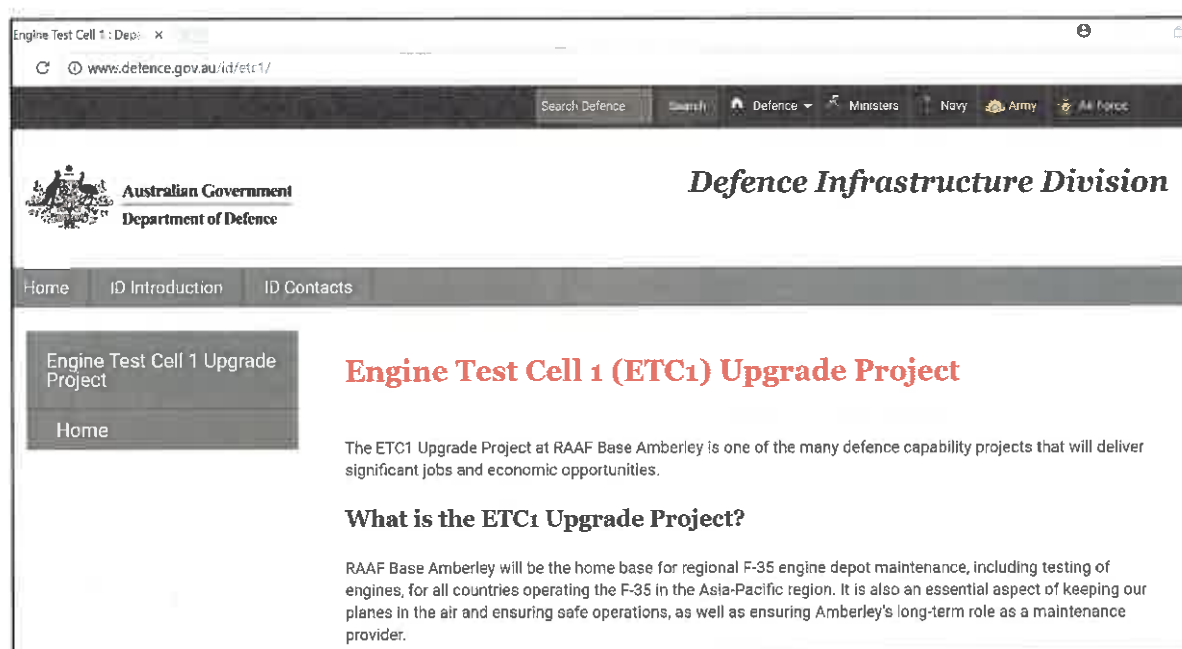

A statement of evidence to the Parliamentary Standing Committee on Public Works in August 2015 revealed the EA-18G Growler, an airborne electronic attack aircraft, was capable of providing force level electronic warfare support by disrupting, deceiving or denying a broad range of military electronic systems, including radars and communications

The aircraft will be able to support the full spectrum of defence tasks, from peacetime evaluation to major conflicts

"12 new-build EA-18G Growler aircraft will operate in conjunction with air, land and sea forces. The capability will reduce the risk to forces and improve their situational awareness," the statement of evidence read
