Inquiry into Canberra's National Institutions

Efficiency Dividend

As outlined in the 2016-17 Budget measure *Public Sector Transformation and the Efficiency Dividend*, the efficiency dividend is 2.5 per cent in 2017-18, 2 per cent in 2018-19 and 1.5 per cent in 2019-20. The annual ED then returns to 1 per cent in 2020-21.
