Update

We seek special permission to update this enquiry after recent developments. On 25 June 2021, the NSW Government issued health orders that relate to our members.¹ These orders take immediate effect and may have an adverse impact on Aviation.

Actions

The governing body of the Australian Licenced Aircraft Engineers Association considered the health orders. We focused on mandatory vaccination and its industrial implications. We concluded that all persons should have a choice to be or not be vaccinated. Details and reasoning are affixed as attachment 1.

Our decision was based on input from 1166 members who responded to the following survey question:

If offered an optional free vaccine today during work hours, would you take it?

Over 21% of members said no. All respondents were Aircraft Engineers who work in Australia. The survey was conducted over April and May 2021. A full copy of the survey is affixed as attachment 2.

Implications

Many Aircraft Engineers will not accept forced vaccination. If forced to decide between vaccination and their jobs, many will walk away from Aviation. That number could be as high as 21% of skilled professionals in our industry. If this number walk away, there will be insufficient Engineers to keep all aircraft flying. Industrial protections need to be developed and implemented to support the choice of persons working in our field.

TO: ALL MEMBERS

RE: COVID EXECUTIVE MOTION

After considerable deliberation, the Federal Executive decided that:

We acknowledge that the pathway to normality must involve widespread vaccination. This is needed for aviation and wider community recovery. We call upon the Federal Government to set a pathway towards recovery with all Australians offered full vaccination by no later than July 2022. After that time, the economy and borders should be opened without restriction. The ALAEA also acknowledges the choice of persons to not be vaccinated. We support the adoption of employment protection for those exercising such choice.

This sets a platform for us to base all related representations and activities. We say it is a motion about choice. We support those who do not want to be exposed to Covid prior to being vaccinated. We also support those against vaccination. It is a call for Governments to plan for a day when we can return to normal. A plan none of them can outline as they focus on political point scoring.

Many want to return to normal now and think 12 months too long. Earlier would be preferable but unrealistic. At the current rate of vaccination, all Australian adults could not be vaccinated prior to April 2022. Arrangements then need to be made for minors. The option of choice goes both ways. You can choose not to be vaccinated now. You cannot choose to be vaccinated until it is offered. We would welcome any earlier supply and delivery of vaccines to bring the uncertainty to an end sooner.

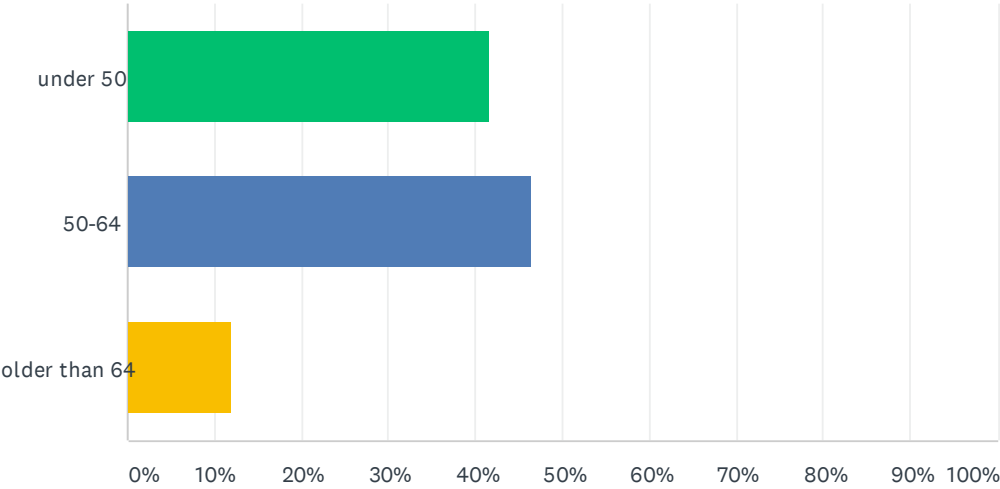
The level of support we can provide those who elect not to be vaccinated is out of our hands. Courtrooms and Governments decide these things. We will do all we can including lobbying, negotiating, mediating and where possible seeking arbitration, to protect your choice. The mandatory vaccination question is an evolving global one far greater than one union.

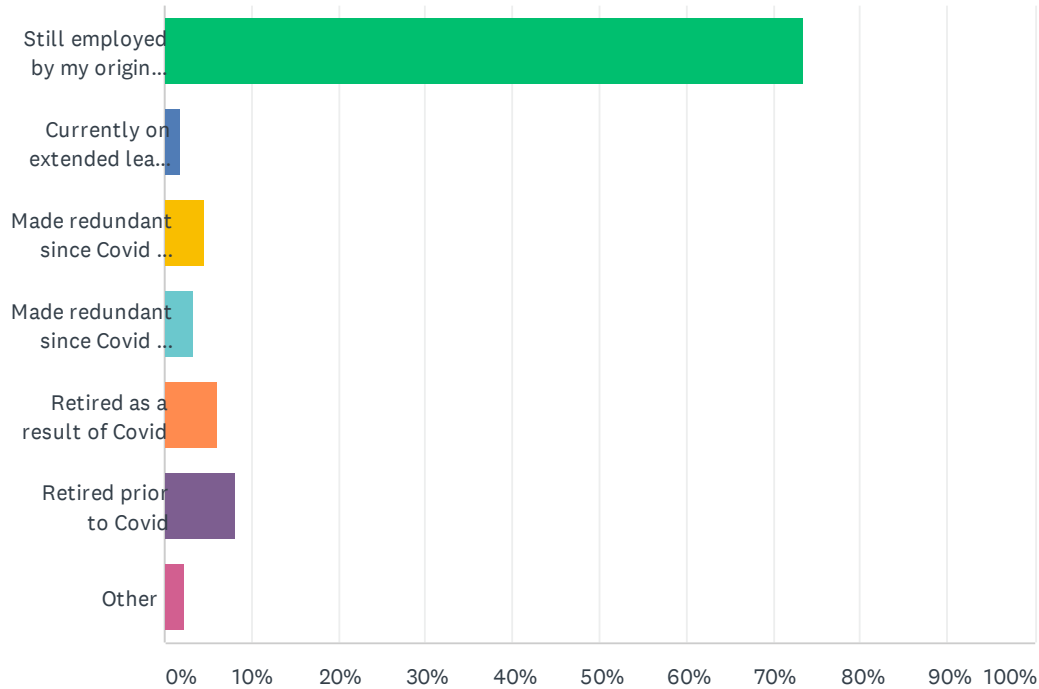

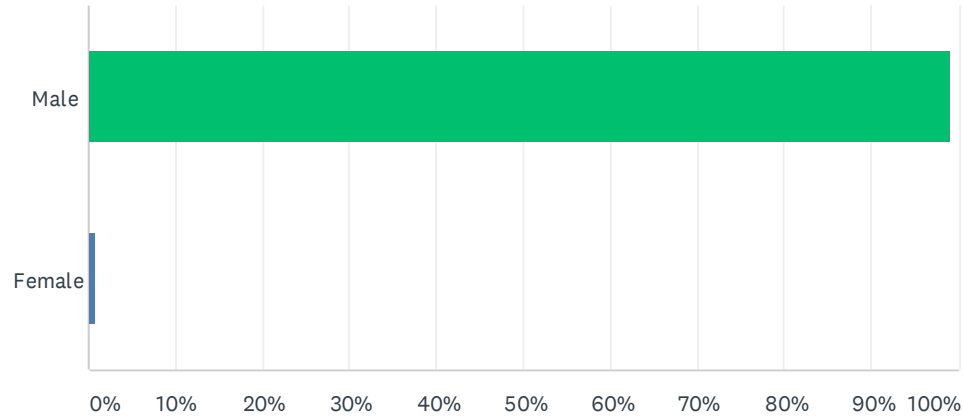

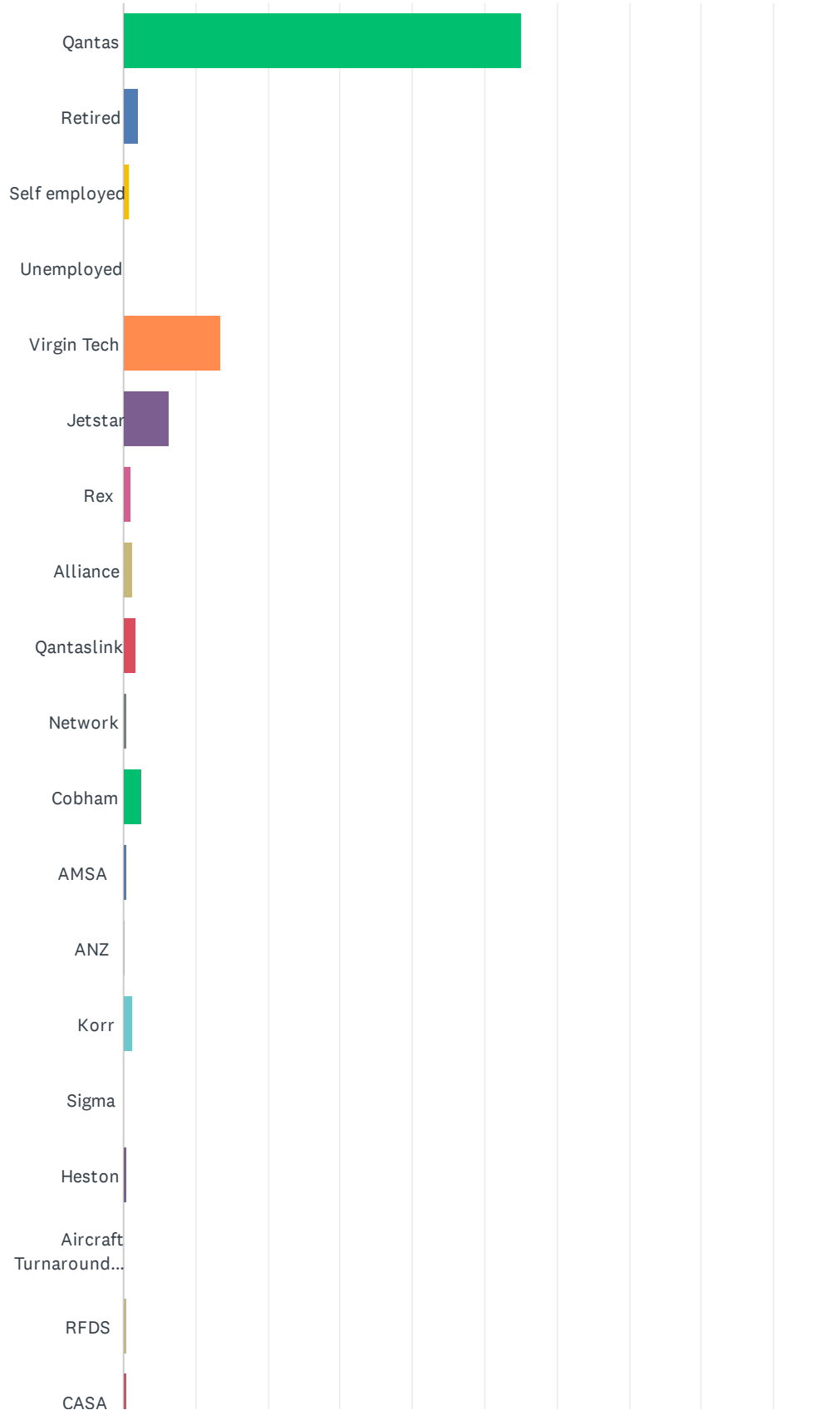

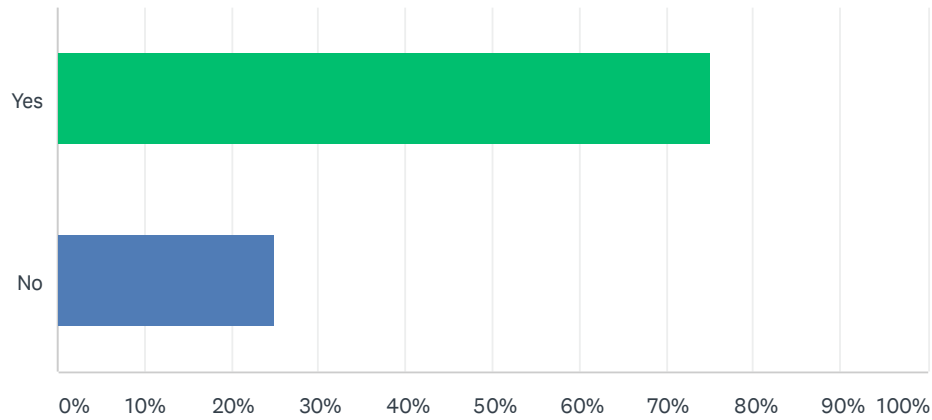

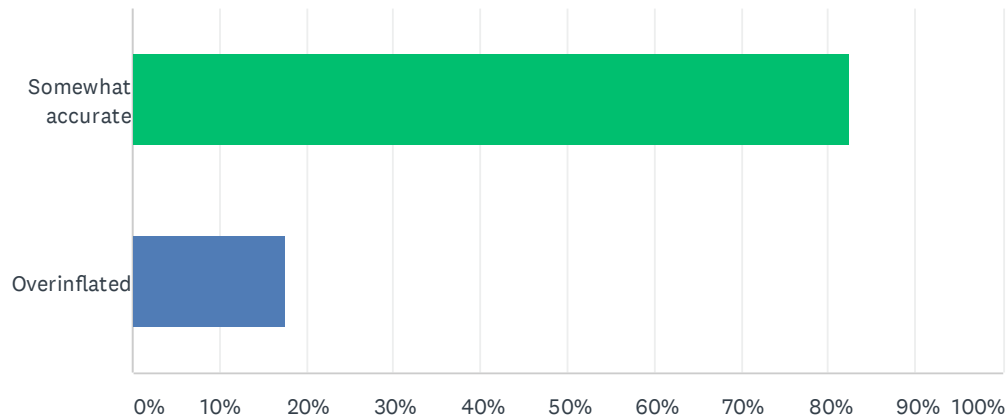

Q6 There are a reported 3 million worldwide deaths attributed to Covid. Do you believe the reported death toll is:

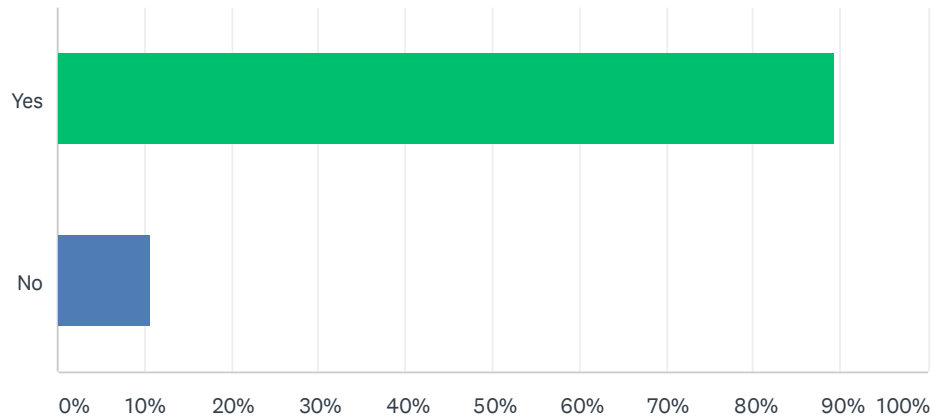

Q7 Do you believe that masks can reduce the spread of Covid?

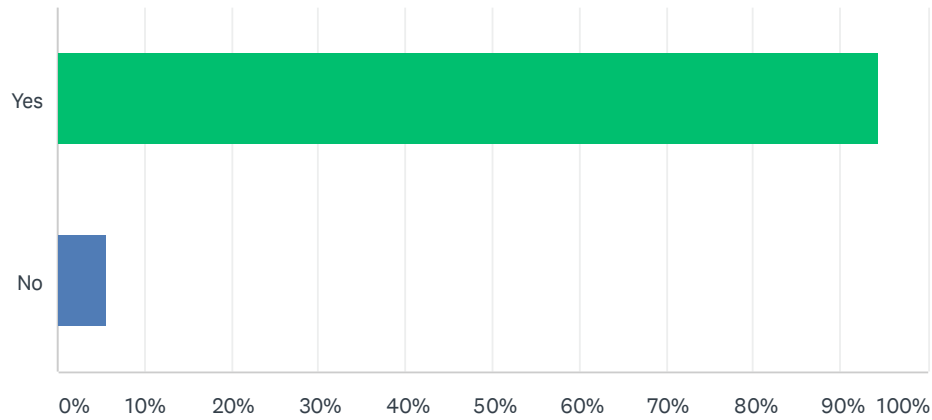

Q8 Are you glad that vaccines have been developed?

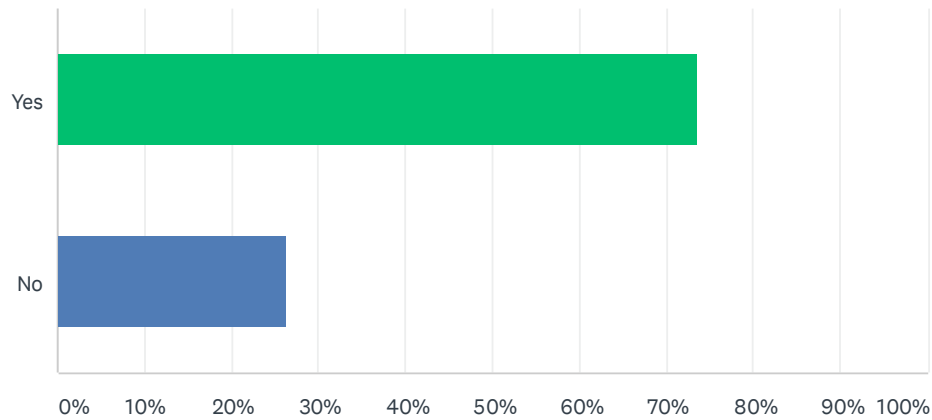

Q9 Do you think Australia and our States have handled the Covid situation well?

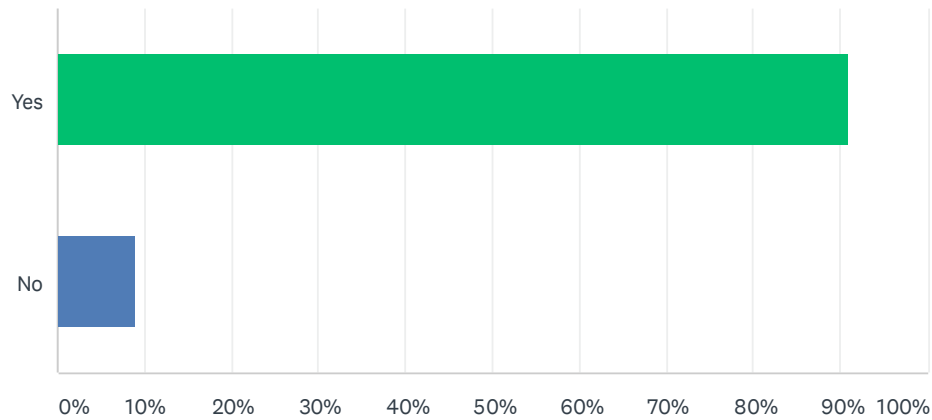

Q10 Do you think we would be in a worse position now if our response to Covid was not so strict?

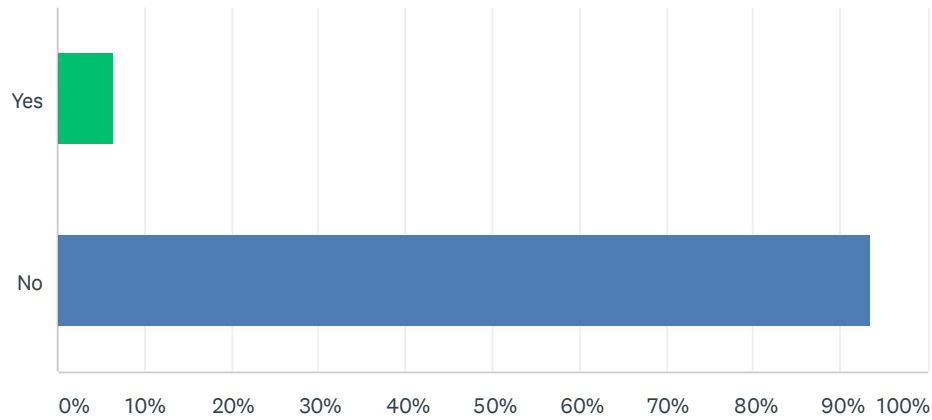

Q11 Do you think International borders should be opened in full now?

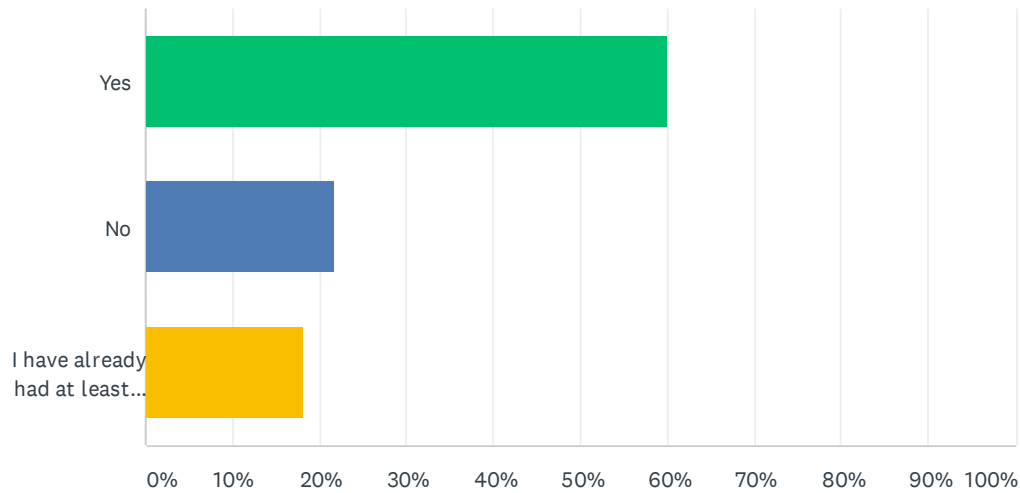

Q12 If offered an optional free vaccine today during work hours, would you take it?

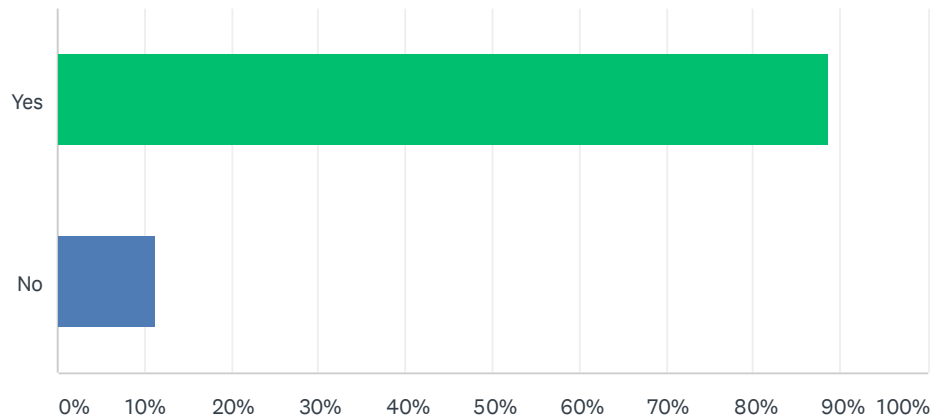

Q13 Are you concerned that if you caught Covid and had no symptoms, you may spread it to family and friends?

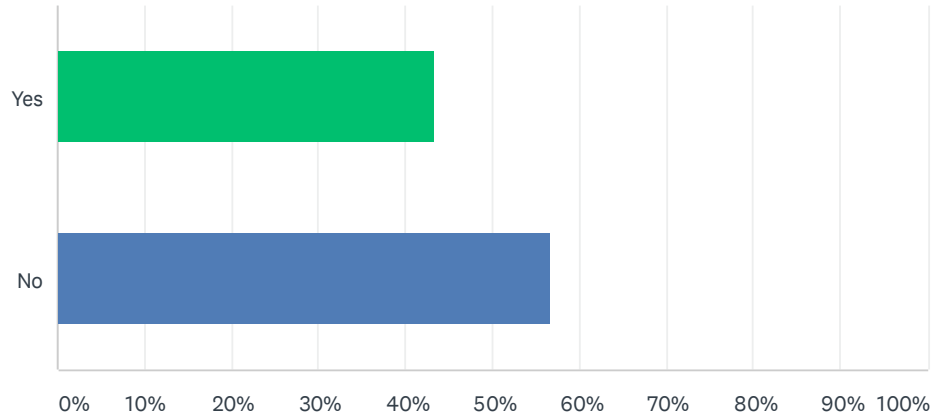

Q14 Do you think mandatory employee Covid vaccinations (unless medically exempt) should be allowed?

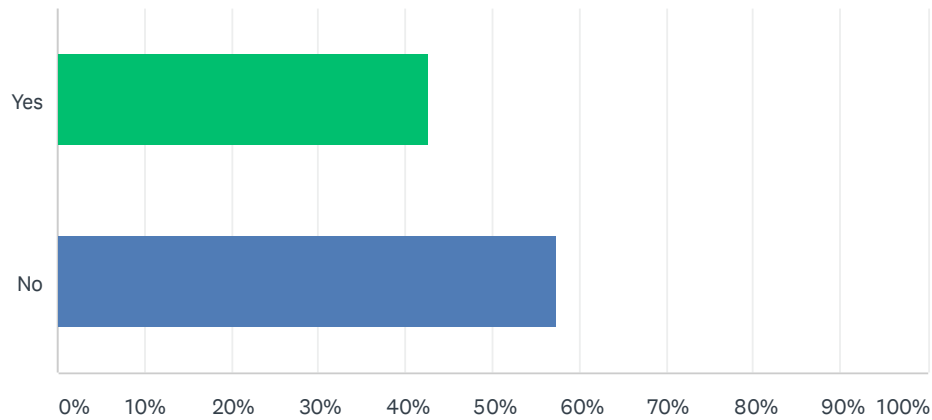

Q15 Should the ALAEA rigorously oppose mandatory employee Covid vaccination?

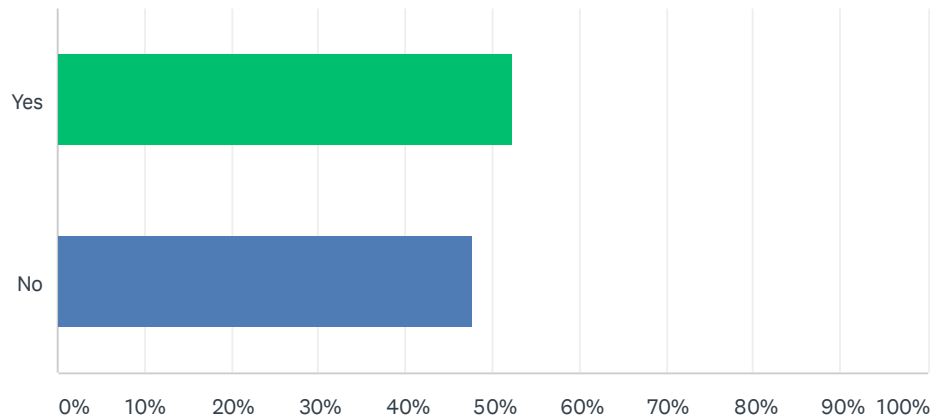

Q16 Would mandatory vaccination be ok if those who opposed vaccination were offered the alternative of a VR package?

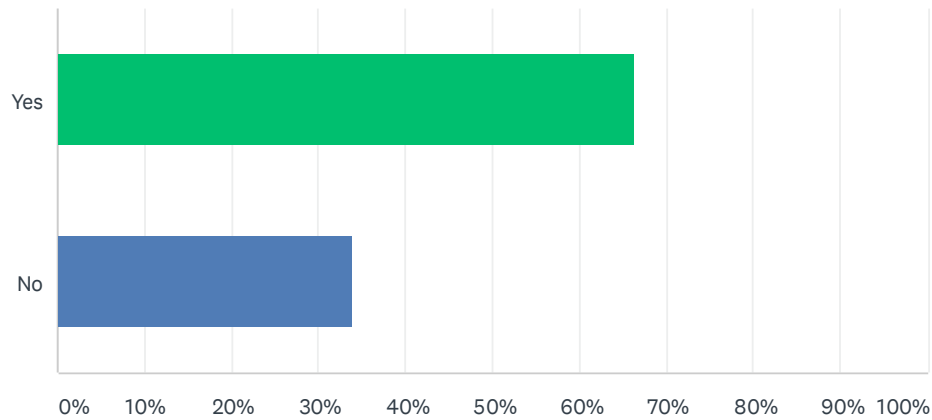

Q17 Would mandatory vaccination be ok if you could choose which Covid vaccine you were given?

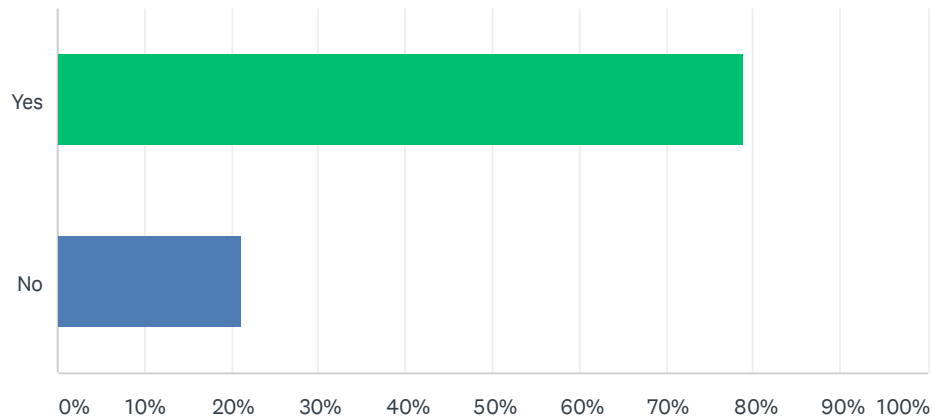

Q18 Should airlines have a policy of all international passengers needing to be fully vaccinated prior to travel?

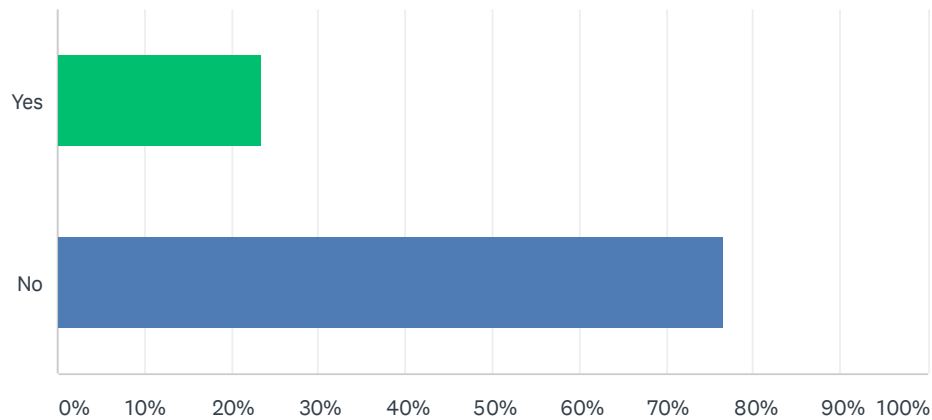
