#### RESEARCH

I investigate the context of the law and how social structures, language, and values affect the substance and practice of the law, specifically in the areas of criminal law, family law, discrimination law, employment law and immigration law. I have built up a strong publication record; strength is evident in terms of quantity, international reach and impact/quality. Important aspects of my research are its applicability to real life issues such as law reform and its nexus with my teaching. My work is multidisciplinary: Law, Sociolegal Studies, Criminology and Women's Studies. I use a range of empirical methodologies from these disciplines including cross-case comparison, in-depth interviews and surveys.
