The Foreign Minister's Office forwarded Virgin Australia's letter of 21 August to the Department of Foreign Affairs and Trade on 22 August 2023.

The letter was provided to the Department for noting. The Department noted the contents of the letter but did not take any specific action as a result.

The Department undertook searches of its records in response to relevant Orders for the Production of Documents. Any documents found to potentially be in scope were provided to ministers to determine whether they were within scope and if they could be provided or would be subject to a public interest immunity claim. The order of the Senate is made of ministers, not the Department, and it is not the Department's role to make a final determination about documents that are and are not within the scope of the order. The outcomes of the ministers' determinations are found in the responses to the orders for production tabled in the Senate.

The Department of Foreign Affairs and Trade did not brief the Minister for Trade and Tourism in relation to the letter from Virgin dated 21 August.
