### Question:

#### Answer:

The Supermarket Taskforce, led by the Department of Home Affairs, was established on 18 March 2020 to respond to challenges facing supermarkets arising from the COVID-19 pandemic, and to coordinate supermarket responses across Australia. The Supermarket Taskforce was established as a collaboration mechanism. Industry cooperation has been critical to stabilising consumer confidence, maintaining equitable access to food and minimising negative impacts, including health risks, for supermarket staff and customers.

There are a range of areas where participants in the Supermarket Taskforce cooperated in responding to COVID-19, supported by an Australian Competition and Consumer and Commission authorisation. These areas of cooperation have included:

- changing in-store operations to support social distancing such as developing and implementing industry-led voluntary customer limits in stores
- approaching state and territory governments to adjust trading hours while managing demand (around Easter and ANZAC Day; daily community hours)
- scaling-up home delivery and click and collect services, and prioritising vulnerable people for these services
- industry-imposed limits on items subject to excess demand
- discussing item limits to manage demand for certain goods and cooperating to support supply of certain goods to remote and regional Australia
- approaching AusPayNet to trial increased contactless card transaction limits.

The Supermarket Taskforce has not provided recommendations to the Australian Government Cabinet or the National Cabinet. Updates on collaborative activities undertaken by the Supermarket Taskforce were provided via the National Coordination Mechanism.

The Department of Agriculture, Water and the Environment (DAWE) received a document from the New South Wales Department of Primary Industries on COVID-19 advice for food businesses. DAWE shared this document with both the Supermarket Taskforce and the working group established under the Food Regulation Standing Committee (FRSC).

The document provided to DAWE by the New South Wales Department of Primary Industries was used, along with other state and territory documents, to update the Food Standards Australia New Zealand (FSANZ) website. The FSANZ website is the central point for national food safety advice to consumers and food businesses on COVID-19. The website provides advice for food businesses on COVID-19 and food safety, and links to state and territory specific advice where available.

#### Answer:

The Supermarket Taskforce and its members has been working closely with the National Indigenous Australians Agency (NIAA) and the Department of Agriculture, Water and the Environment (DAWE) to ensure food security and supply to regional and remote communities is a high priority throughout the response to the COVID-19 pandemic. DAWE is the lead agency with policy responsibility for food security.

With supermarket cooperation enabled through the Australian Competition and Consumer Commission (ACCC) interim authorisation, the Supermarket Taskforce has been able to facilitate consumer access to products in regional and remote communities. For example, major retailers have cooperated to facilitate the supply of food and grocery products, such as flour, to remote regional communities in Northern Territory and far north Queensland.

Additionally, the NIAA has established a Remote Food Security Working Group, of which some Supermarket Taskforce members are participants. The NIAA Remote Food Security Working Group brings together community store management companies, suppliers, and state and territory governments to identify issues impacting remote food security and to escalate them for resolution to the appropriate state, territory or national forums as required through the Hon Ken Wyatt MP, Minister for Indigenous Australians, and the Supermarket Taskforce.
