And This Was Stated By New South Wales State Lawyers For The State Of New South Wales And This Was A Court of Appeal The Plaintiff Against The State Of New South Wales Banco Supreme Court Of Appeal 18th August 2008, Sydney Supreme Court Of Appeal.

I Would Like For All Court Cases Of Which Their Claims Were Submitted Through The Courts To Be Re Opened And Granted The Sum Of Which They Applied Through The Courts Of Which The Courts Have Dismissed.

For Those Of The Perpetrators Who Are No Longer Alive For Their Death Certificates Be Marked With These Crimes Against Their Names For The Crimes They Did To Us As Children.

A Royal Commission Into The Past Practices And Corruption And Cover Ups Of What Us Victims Suffered In These Institutional Homes With In Australia.

For All Perpetrators To Be Convicted And Sentenced To Gaol.

I was in an institution run by the state of NSW daruk boys home Windsor also known as Dharruk training school for boys now known as the john maroney correctional centre i was raped and abused by 2 perpetrators and was abused emotionally i have never had a quality of life what is that ?

I was in this institution 1976/1977/1978 and was repeatedly sexually abused emotionally and mentally abused made a slave and starved and made feel like i was worthless the abuse we suffered each day was horrific and it will stay with me for the rest of my life i still suffer to this day with what this has done to me as a man failed relationships break ups of families no family no friends and at times a pitiful lonely life from these things that happened to me in this state run institution give us a better quality of life we are damaged beyond repair and we should be compensated fully for these crimes that where inflicted upon us as children.
