**COMMUNITY CONSULTATION REPORT – JOINT HEALTH COMMAND  
GARRISON HEALTH FACILITIES UPGRADE PROJECT**

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of communication and community consultation undertaken as part of the proposed Joint Health Command Garrison Health Facilities Upgrade Project (the Project).

The objective of the community consultation undertaken by Defence was to ensure that base and other stakeholders and the community were:

- a. well informed about the Project by using effective and proven communication channels to convey details of the proposed works; and
- b. had every opportunity to raise issues of concern or seek further information so that wherever feasible, they could be addressed by Defence in its program of works.

The communication and engagement activities listed below were delivered in accordance with the Project's comprehensive Communication and Engagement Plan, namely:

- a. Correspondence via email and phone to key stakeholders. A list of all internal and external stakeholders consulted is at Annex A, with a short description of the outcomes of the consultation. An example of the emails sent to stakeholders is provided at Annex B.
- b. Advertisements promoting the four Public Information Sessions, describing the project and directing people to the digital engagement platform, were placed in local newspapers and *The Australian* in the week beginning 27 November 2017. An example of these advertisements is provided at Annex C.
- c. Letterbox drops to neighbouring residential areas potentially affected by site works and construction vehicle traffic paths were conducted on 27 November 2017. Approximately 850 letters were distributed across seven out of the 13 sites, providing project information, contact details and a website address. An example of these letters and their distribution is provided at Annex D. No letterbox drops were provided to the other six sites as they were located in non-residential areas (eg, Russell in the ACT) or

were isolated bases. These sites were therefore captured in the digital engagement platform.

- d. A digital engagement platform was launched on 27 November 2017 and will be taken down on Tuesday, 30 January 2018. The site, [www.jhcfacilitiesupgrade.com](http://www.jhcfacilitiesupgrade.com), consists of a home page with positioning information about the project, individual pages for each site, downloadable hard copy fact sheets in both standard and accessible format and an inbuilt survey to collect questions or feedback. A snapshot of the website homepage is at Annex E.
- e. Four Public Information Sessions and a Residents Briefing Session (at Royal Military College – Duntroon) were held in the week beginning 11 December 2017, as detailed at Annex F, with examples of display and printed materials at Annex G.

Whilst there was limited public participation across the provided communication channels and engagement activities, there were no objections raised to the proposed works. There were some minor concerns raised about traffic, dust and noise during construction; but there are no major issues or concerns that require further action. Defence will continue to manage these issues until construction is completed.

Defence is satisfied that it has taken all reasonable steps to inform the Community about the Project and to provide opportunities for the Community to raise any concerns and questions.



The \$212m project will centralise and co-locate most on-base health services. These facilities will support all forms of Australian Defence Force operations and personnel through the provision of primary healthcare and associated services.

The project will make a significant contribution to operational efficiencies in Garrison Health Services delivery, while ensuring facilities comply with Defence's clinical governance framework. The project is expected to provide substantial improvements and efficiencies in health support at 13 priority sites around Australia.

Investigations and health need assessments have been undertaken at each site, to understand what the facilities must deliver now and into the future.

In line with this, new health care facilities will be built at Puckapunyal Military Area (Seymour, VIC) South Bandiana (Albury-Wodonga, VIC) Simpson Barracks (Watsonia, VIC), Larrakeyah Barracks (Darwin, NT), Campbell Barracks (Perth, WA), Royal Military College Duntroon (Canberra, ACT), Oakey Army Aviation Centre (Oakey, QLD) and RAAF Townsville (Townsville, QLD).

Existing health care centres at Gallipoli Barracks (Enoggera, QLD), Robertson Barracks (Darwin, NT), Holsworthy Barracks (Holsworthy, NSW) and Russell Clinic (Canberra, ACT) will be refurbished.

Construction of the new health care facility at Oakey Army Aviation Centre is expected to start in early 2018, cost \$20m and take 14 months to complete.

### Online survey

Feedback collected from the online survey indicated:

- There was community concern for traffic, dust and noise issues associated with construction works at Oakey Barracks and Simpson Barracks.
- One resident from Oakey expressed frustration at the impact of current projects and issues, in particular PFAS contamination.

**PUBLIC INFORMATION SESSIONS**

There was limited participation across all communications channels and engagement activities, suggesting key stakeholders and the community had little interest in the project and any associated impacts.

There were no objections to the proposed works, however there were requests for further information. All four requests were in response to the project materials released, particularly emails and letters.
