Membership

The Foster Care Association of Victoria (FCAV) is pleased to welcome the 893 new members who joined in the past year, bringing our total membership to 4197. This increase in membership is significant in the light of continuing issues facing the foster care sector. As membership grows, the FCAV is broadened in its scope, enhancing our understanding of the range of issues impacting Victorian carers. It is this understanding that feeds into focusing and strengthening our capacity for advocacy.

Carer Snapshot

The FCAV undertakes an annual audit of foster care households which, this year, showed a dramatic increase in numbers of 'non-active' carers and a reduction in the number of potential carers undertaking accreditation. The key challenge for Victoria is retaining those within the system. Improving conditions for those already active foster carers is vital to grow a sustainable pool of households that are able to meet the needs of children requiring care.

During 2013-14 the Foster Care Association of Victoria (FCAV) worked to engage carers across the state. Hundreds of carers and workers attended our training workshops in Geelong, Horsham, Bendigo, Shepparton and Melbourne's northern and southern suburbs.

Additionally, our staff attended numerous events, carer consultations and meetings with local members of parliament across Gippsland, the Mornington Peninsula and the Mallee, as well as Warrnambool, Mildura and Ballarat.

We have become familiar with local challenges and inconsistent practices across the different regions, which are impacting carers and the wider system. This knowledge is relayed back to DHS head office, politicians and other sector leaders, and incorporated into the FCAV's advocacy.

During the year ahead we will host carer development sessions in 12 locations across the state. Three sessions will be staged in the Melbourne metropolitan areas, and 8 sessions will be held regionally in Ballarat, Bendigo, Horsham, Mildura, Morwell, Shepparton, Warrnambool, and Wodonga. 
With a growing membership and mounting challenges, it was no surprise that calls to the Foster Care Association of Victoria's (FCAV) Carer Information and Support Service (CISS) grew throughout 2013-14.

The total number of requests for support and information increased by 18%, while the team addressed 31% more individual issues than in the preceding year. This included 23% more inquiries from foster carers alongside an increase of 32% in numbers of questions from workers.

Inquiries related specifically to foster care comprised 508 contacts or 84% of all inquiries - a 23% increase from 2012/13. CISS identified 792 issues of concern regarding foster care, constituting 75% of all issues raised by contacts to the service - a 34% increase from 2012/13.

voice of carers

The FCAV's 'Voice of Carers' report ...has been shared with representatives from all sides of politics, agencies, DHS staff and other carers."



Foster Care Association of Victoria (FCAV) members regularly express frustration that their voices aren't heard clearly by those that make decisions impacting the children in their care. We believe that your expertise should be heard by agencies, politicians and DHS staff, so this year the Association set out to promote it in a range of new ways.

At our last Annual General Meeting, carers were invited to leave suggestions for system improvements on the 'Voice of Carers' tree. These suggestions were then compiled into the 'Voice of Carers' report, which has been shared with representatives from all sides of politics, agencies, DHS staff and other carers. At FCAV training events, carers were asked to share the core elements of their 'dream' placement. These included heartbreakingly simple reforms, like 'telling children in an age-appropriate way why they are not at home with their parents'. These ideas formed the 'Perfect Placement' report, which has been passed onto agencies, DHS staff and used to start many conversations with other carers.

advocacy

Through extensive consultations with our membership, it became clear that financial pressures on carers are greater than ever.



The Foster Care Association of Victoria (FCAV) has ramped up advocacy efforts over the past year in response to growing concerns amongst Victorian foster carers. As well as participating in a range of working groups and advisory committees, we have formed a coalition of foster care agencies to campaign for specific improvements.

Through extensive consultations with our membership, it has become clear that financial pressures on carers are greater than ever. This, combined with diminishing respect, recognition and support, were the primary factors driving carers away from the system, while discouraging new volunteers.

While we will continue to advocate for a wide range of reforms, our focus for the 2014 state election will be on five core issues. We are asking for a commitment from all political parties and parliamentarians to:

- 1. Increase foster care reimbursements to meet the true costs of caring for children.
- 2. Ensure the education, medical, allied health and recreational expenses for children in foster care are met by the state not the carer.
- 3. Implement and fund a coordinated, state-wide foster care recruitment and retention program.
- 4. Improve state-wide access to ongoing training, practical support and regular respite for carers.
- 5. Support calls for the Commonwealth to remove income tests from carers' access to benefits for children in foster care.

treasurer's report

The Foster Care Association of Victoria (FCAV) continues to maintain a strong financial position reporting an operating loss of \$2,781 for the financial year ending 2013/14, beating budget expectations by 80%.

This deficit means that the FCAV has performed better than our budget expectation which was predicting an operating loss to the value of \$13,961. Profits carried forward from previous years were used to fund the deficit.

It is important to note that this financial achievement is even more pronounced when you take into account the number of things that the FCAV has managed to do throughout this year.

This was all done along with our regular activities which included the production and distribution of the FCAV Carers' newsletter, responding to calls made to the Foster Care Helpline, and liaising with local and regional support groups in relation to training.

A cash balance at the end of June 2014 of \$137,206 was held. Funds continue to be closely monitored.

My role as treasurer has been enjoyable, largely due to the wonderful ability of our CEO to work within the organisation's budget. I would also like to thank Andrew Mamalis for the great job that he does as FCAV's bookkeeper.
