- a. The number of people who have travelled as part of the response to the COVID-19 outbreak, including the provision of aid
- b. The number of people who have travelled because their travel is essential for the conduct of critical industries and business (including export and import industries)
- c. The number of people who have travelled because their travel is for urgent medical treatment that is not available in Australia
- d. The number of people who have travelled because their travel is for urgent and unavoidable personal business
- e. The number of people who have travelled because they are travelling on compassionate or humanitarian grounds
- f. The number of people who have travelled because their travel is in the national interest

Please provide monthly data for air arrivals into Australia from 1 April 2020 to 25 September to indicate the following. If this exact data is not available, please provide whatever data is available to help the COVID-19 Select Committee to understand the numbers of people arriving into Australia and under what categories, and what proportion are moving into quarantine.

- a. The number of people who arrived into Australia in total
 - i. The proportion of these people who were required to enter hotel quarantine
- b. The number of Australians, permanent residents, immediate family members of citizens/permanent residents, NZ citizens usually resident in Australia and their immediate family members
 - i. The proportion of these people who were required to enter hotel quarantine
- c. The number of diplomats accredited to Australia (holding a subclass 995 visa)
 - i. The proportion of these people who were required to enter hotel quarantine
- d. The number of people recruited under the Government approved Seasonal Worker Program or Pacific Labour Scheme
 - i. The proportion of these people who were required to enter hotel quarantine
- e. The number of people on a Business Innovation and Investment (subclass 188) visa

The Australian Border Force (ABF) does not hold data on:

- The number of travellers that arrived into Australia and entered mandatory quarantine under state and territory health arrangements.
- The immediate family members that may have returned to Australia with Australian citizens, permanent residents and New Zealand Citizens that usually reside in Australia.
- The number of diplomats accredited to Australia (holding a subclass 966 visa). The Department of Foreign Affairs and Trade are the responsible agency for accrediting foreign diplomats in Australia. The figures in table 1 represent travellers who entered Australia on a Diplomatic (International Relations) (subclass 955) visa.

It is not possible to provide detailed data in response to part E, K and L without a manual examination of individual records which would involve an unreasonable diversion of resources. The ABF however provides the following available data to assist the Committee:

- In response to part E, the number of travellers who entered Australia on a Business Innovations and Investment (subclass 188) visa.
- In response to part K, the number of military personnel who arrived via a Special Purpose Military Travel Authority.
- In response to part L, the number travellers who entered Australia on student visas and were aged between 16 to 20 years.

In response to part I, to provide the number of people who arrived and were non-citizens sponsored by an employer to work in Australia in an occupation on the Priority Migrant Skilled Occupation List would require manual examination of individual records which would involve an unreasonable diversion of resources

In response to part M the data available to the ABF does not differentiate the travelers that arrived into Australia for compassionate and compelling reasons.

In response to part F, G, H and J the ABF does not hold data that meets this request.
