Ouestion:

What if a person has not yet received their pay slip at the date they are required to report income for the period? What will they be expected to do – will they have to estimate?

Answer:

Under the change of assessment model people will be required to report their income paid for the reporting period. If they have not received income in the reporting period, they will report zero income.

If they have received income (ie. received a salary payment from their employer) but have not yet received their payslip, people should contact their employer for their employment income information. Employers have an obligation to issue employees with a payslip, either digitally or in hard copy.

If someone does not have a payslip and has difficulty in obtaining information from their employer, they should contact Services Australia to discuss their circumstances and how they can meet their reporting obligations to enable them to access their social security payment.
