1. Provide breakdown of the \$180,000 that Woodside provided in 2012-2013 to the Liberal Party.

Answer: The breakdown of the \$180,000 to the Liberal Party included payments to the WA Division (\$61,150) and the Federal Liberal Party (\$120,000) as detailed below, and as reported to the Australian Electoral Commission. The \$110,000 payment relates to the membership fee for the Australian Business Network. Similarly, Woodside subscribed to the Federal Labor Business Forum (\$110,000) and payment to the WA Branch of the Labor Party (\$50,000).

Woodside spent an additional \$30,480 attending conferences and other business events associated with political parties (see details below Q5). These payments were treated as non-deductible for income tax purposes.
