I, THERESE PARISH (K.A) TERI HAY, AM A CITIZEN OF THE COMMONWEALTH OF AUSTRALIA AND A RESIDENT OF QUEENSLAND.

AS A CITIZEN OF THE COMMONWEALTH AFFORDS ME PROTECTION FROM THE UNLAWFUL AND HARMFUL ACTIONS THAT THREATEN MY RIGHT TO LIFE, LIBERTY AND JUSTICE FROM THOSE WHO WOULD DENY ME THOSE RIGHTS WITHIN OR WITHOUT THE BORDERS OF AUSTRALIA.

MY DAUGHTER (...) WAS STOLEN FROM ME AT BIRTH, ON ORDERS FROM (...) (SOCIAL WORKER). I WAS FORCED TO GIVE BIRTH ON INDUCTION AFTER 13 HRS AND 10 MINUTES. I WAS DRUGGED WITH STILBOTAL AND MY FACE AND BODY WERE COVERED BY AN (...) LABOUR WARD NURSE AT THE KING GEORGE HOSPITAL CAMPERDOWN, N.S.W.

(...) STOLE MY THREE DAUGHTERS AFTER I PHONED NEWTONN. CHILD WELFARE FOR HELP TO PAY 3 POUNDS 10 SHILLINGS ELECTRICITY BILL AT 10 TO 10 AM, (...) AND A LONG DARK HAired YOUNG GIRL ARRIVED AT 3-50 PM, THEIR EXCUSE WAS THEY COULDN'T HELP ME AS THE OFFICE WAS CLOSED SO THEY WILL TAKE THE CHILDREN UNTIL MONDAY. MONDAY NEVER CAME. I WAS PLACED IN TRISSILLIAN HOME BEFORE (...) BIRTH AND COERCED INTO ADOPTING HER AND FIGHT FOR THE GIRLS I KNEW. I REFUSED TO ADOPT & SCREAMED THE SAME FOR MANY HRS AFTER THEY STOLE HER. I ABORTED A CHILD AFTER SO THAT THE WELFARE COULDN'T STEAL

ANOTHER CHILD FROM ME. KING GEORGE HOSPITAL HAS FILES AS I ALMOST DIED FROM HEMORRAGE. AFTER MY BABY WAS STOLEN I WAS PLACED ON THE SIXTH FLOOR IN A ROOM ALONE, I WAS DENIED SEEING MY BABY EVEN THOUGH I PLEADED THROUGH HEART ACHE AND TEARS FOR HRS "TO GIVE ME MY BABY". (...) GAVE ME NO HELP OR ADVICE ON HOW TO COPE WITH MY FEELINGS, I WAS SEDATED FOR DAYS AFTER HER BIRTH.

THERE WERE NO REASON FOR (...) ((...) TO DO THIS TO ME, MY HUSBAND HAD LEFT AND OF COURSE I COULD NEVER RETURN TO THE MARRIAGE AS MY HEARTACHE HAD TURNED BITTER AND HAD NO LOVE LEFT ONLY A MOTHERS LOVE FOR MY CHILDREN I SO DESPERATELY WANTED BACK, WHICH I NEVER SAW AGAIN FOR YRS, UNTIL AT 15 YRS, 24 YRS AND 29 YRS THEY FOUND ME AND NEVER BELIEVED WHAT I TOLD THEM.

I DO NOT KNOW ANY OF MY DAUGHTERS TODAY AND HAVE NOT FOR 14 YRS. MY ELDEST GIRL (...) WAS KILLED WHILE WITH FOSTER PARENTS. I HAVE HER CORONERS REPORT AND (...) WAS THE LAST MAN TO HAVE HER FILE IN 1969 AND HAVE BEEN MISSING ALL THESE YEARS SINCE AS I HAVE TRIED HUNDREDS OF TIMES TO CLAIM THEM AND HAVE BEEN LIED TO BECAUSE I KNOW THE CORRUPTION BEHIND HER DEATH IS COVERED BY THE WELFARE. I HAVE BEGGED FOR 46 YRS FOR A REASON "WHY", NO REPLIES. I WANT SOME JUSTICE, ITS TOO LATE FOR "SORRY", ITS ONLY A WORD. I CAN ONLY HOPE THAT NOW SOMEONE WILL HEAR MY PLEAS.
