Question:

- 1. Please provide the following figures based on the latest available data point:
- a. How many businesses have received JobKeeper payments
- b. How many employees have received JobKeeper payments through their employer
- c. The table on the early access super scheme first provided to the Committee on 11 June in $QoN\ IQ20-000109$
- 2. Will Treasury provide a fortnightly update of these figures to the Committee
- 3. How regularly will Treasury update the JobKeeper postcode data available on its website, and what will the lag time be for this data

Answer:

1. Please provide the following figures based on the latest available data point:

a. How many businesses have received JobKeeper payments

As at Sunday 19 July, 965,536 unique ABN's have had applications processed for a JobKeeper payment in April, May, and/or June.

Once an organisation has an application processed, the ATO aims to make payment within 4-5 business days unless the payment has been supressed due to compliance reasons.

b. How many employees have received JobKeeper payments through their employer?

As at Sunday 19 July, the number of employees and eligible business participants nominated by their employers for the JobKeeper payment, by month, was:

April: 3,350,274¹
May: 3,552,189¹
June: 3,362,660*

*Note that applications for the June JobKeeper fortnights only opened on 1 July.

¹ The figures relating to April and May will continue to rise gradually, as a small number of applications are still being accepted for April and May, but employers must contact the ATO so that they can process manually.

The above figures are not cumulative as the employees and eligible business participants are not unique. That is, employees and eligible business participants may have received JobKeeper payments for April, May and June or only for one/two of those months.

c. The table on the early access super scheme first provided to the Committee on 11 June in QoN IQ20-000109

Since the commencement of the measure, a total of 2,636,229 individual applicants have been approved to release \$31.6 billion of their superannuation under the COVID early release measure (data as at 26 July 2020). This comprises 2,453,050 individuals in 2019-20 and 183,179 unique applicants in 2020-21 (to date). Of the total number of applicants approved in 2020-21 to date, 86 per cent have also applied in 2019-20 (data as at 26 July 2020).

2. Will Treasury provide a fortnightly update of these figures to the Committee?

The Department of Treasury has been providing updated JobKeeper data through its appearances at the Senate Select Committee on COVID-19 and responses to Questions on Notice from the Committee.

3. How regularly will Treasury update the JobKeeper postcode data available on its website, and what will the lag time be for this data?

Treasury intends to update the JobKeeper postcode data once the bulk of payments related to a particular month have been made and the data have been quality assured. The publication time will depend on any issues uncovered in the quality assurance process along with competing priorities.
