as I told you I 55 wear glass and hearing aid because I am now on a Disability Pension can't afford good glass or hearing aid so get the cheap one pay by the federal government on the government system for pension.

We should have a pay out for every year we service in care. it should be 10,000 for each year service and 100,000 of pay on suffering or a extra 10,000 per year if you want for pain and suffering that is \$10,000 ~~per~~ year.

for 12 years of my life ~~with~~ is \$120,000 and 10,000 a year for pain & suffering ^{with \$120,000} ~~for~~ \$100,000 for pain & suffering ~~with~~ is less.
