**Mandate of the Special Rapporteur on extrajudicial, summary or arbitrary executions**

28 June 2022

Dear Prof. Bassed,

I am writing in my capacity as United Nations Special Rapporteur on extrajudicial, summary or arbitrary executions to express my gratitude for the invaluable support offered to my mandate by Monash University's Global Research Initiative on Forensic Medicine and Human Rights (GRIFM), including for the preparation of the report which I presented to the Human Rights Council on 22 June 2022.

The report, which examines the role and capacity of medico-legal and forensic services worldwide for investigations into unlawful deaths, is based on unprecedented research on the performance of medico-legal death investigations vis a vis international human rights standards, including the Minnesota Protocol for the Investigation of Potentially Unlawful Death (2016). It illustrates the principal issues and shortfalls, as well as opportunities for improving medico-legal death investigations and it offers a set of practical recommendation on this regard.

I have no doubt that this report stands as a milestone and will contribute to improving medico-legal death investigations in many contexts. I also hope that the report will catalyse further interest and garner support for furthering academic research into this fascinating field and thus contributing to improving human rights protection worldwide.
