Ouestion:

In relation to the funding for the prevention of family violence announced as part of the coronavirus crisis response in March:

- a. What is the total value of the funding announced? How has it been provisioned across financial years?
- b. How much of this funding has already been received by organisations?
- c. Provide a list of funded organisations outlining the amount received and the purpose of the funding, by state/territory and CED?
- d. How much funding was provided to the states? What has this been used for in each state/territory?
- e. How many additional people will be assisted by this funding?
- f. What changes in demand for services have occurred since the start of the Coronavirus crisis?
- g. What stakeholders were consulted prior to the announcement of the additional funding please provide a list?
- h. Please list all family violence prevention services that have contacted the department or Minister requesting additional support in the context of the Coronavirus crisis?

Answer:

A. The total value of the Australian Government's Domestic Violence Support Package is \$150 million. A National Partnership on Covid-19 Domestic and Family Violence Responses will provide an estimated \$32.5 million in 2019-20 and \$97.5 million in 2020-21 directly to state and territory governments to support frontline services to meet demand during this time. \$20 million, of the \$150 million, will be provided to boost other Commonwealth-funded programs over six months across the 2019-20 and 2020-21 financial years.

B. Of the \$130 million being provided to states and territories, an immediate payment of \$27.8 million was made to jurisdictions on 7 May upon signing the agreement. A further \$4.7 million will be paid on 9 June. States and territories are required to report on funding allocations under a National Partnership Agreement. The final report is due in 2021.

The department monitors the impact of the coronavirus pandemic nationally through the Council of Australian Government's (COAG) Women's Safety Council and its senior officials groups. These for have been meeting regularly during the coronavirus pandemic to discuss the impact on service providers due to the increase in service demand and complexity during this period.
- H. The department is unaware of any family violence prevention service that have contacted it requesting additional support in the context of the Coronavirus crisis. Service providers seeking coronavirus funding should contact their relevant state or territory government or Minister.
