**COMMUNITY CONSULTATION REPORT  
EDINBURGH DEFENCE PRECINCT MID TERM REFRESH**

1. The Edinburgh Defence Precinct Mid Term Refresh (the Project) was referred to the Parliamentary Standing Committee on Public Works on 3 August 2023. The Project proposes to deliver facilities and infrastructure at:
  - a. RAAF Base Edinburgh, South Australia; and
  - b. Defence Science and Technology – Edinburgh, South Australia.
2. This letter is to inform the Committee of the nature and extent of community consultation that has been undertaken by the Department of Defence for these proposed works. The aim of the consultation is to ensure local communities and other stakeholders are:
  - a. well informed about this Project details through effective and proven communication channels; and
  - b. provided the opportunity to raise any concerns or issues, or to seek further information so that, wherever feasible, Defence could address these in its proposed works.
3. The following stakeholder and community consultation activities were delivered in accordance with the Project's comprehensive community engagement strategy:
  - a. Advertisement of community information sessions in relevant South Australian local newspapers and establishment of a project email address to receive submissions and questions about the Project. These details are included in the example advertisement shown at **Annex A**,

- b. Two community information sessions were held, one in the City of Playford and one in the City of Salisbury on 26 July 2023 and 27 July 2023, respectively. The type of information Defence presented to the public is shown at **Annex B**, and the level of attendance is provided at **Annex C**; and
  - c. Personal briefings to key stakeholders, including Federal, State and Local Members of Government, and local community and business groups to inform them about the Project. An example of the invitation that was sent out is at **Annex D**, and a list of all stakeholders engaged by the Project, including the status of each engagement, is provided at **Annex E**.
4. A summary of topics and key issues raised during community information sessions is provided at **Annex F**.
  5. Information about the proposed works was generally well received at the community information sessions and feedback to date has been supportive. Defence has not been made aware of any objections to the proposed works.
  6. Comments raised by members of the community focused on:
    - a. Power infrastructure upgrades by the Project and any impacts to surrounding power network and area,
    - b. Project considerations for the City of Salisbury’s stormwater catchment area; and
    - c. Opportunities for local industry participation and local employment.
  7. Consultation activities are continuing, with potential for Defence to provide further briefings to Federal, State and Local Members of Government. These ongoing activities will be further advised at the upcoming Hearing.





On behalf of the Department of Defence, I would like to offer you a personal briefing on the proposed works at RAAF Base Edinburgh and Defence Science and Technology Edinburgh under the Edinburgh Defence Precinct Mid Term Refresh Project. The aim of the Project is to provide fit-for-purpose facilities and infrastructure across the Edinburgh Defence Precinct. The proposed works include replacing or upgrading engineering services and associated facilities and infrastructure that are aged and approaching the end of useful life, have capacity and compliance issues, and pose risks to current and future functions.
