Senator BIRMINGHAM asked:

How many homes and what percentage of all those where insulation was installed under the Home Insulation Program are identified as at risk of having electrified rooves; faulty installation that could cause house fires; inferior or non-compliant insulation products; and inferior or non-compliant installation of insulation products?

Answer/s:

The Minister Assisting the Minister for Climate Change and Energy Efficiency, the Hon Greg Combet AM MP, informed the Parliament on 10 March 2010 that an inspection regime which has completed approximately 15,000 roof inspections to date, and over 1,000 desktop audits has identified:

- 66 per cent of installations were fully compliant;
- 7.6 per cent had fire safety hazards;
- 16 per cent had other quality issues including non-compliant insulation product and incomplete installations;
- 0.5 per cent involved potential fraud; and
- 9.5 per cent were unable to be completed for various reasons.

It should be noted that caution must be exercised in extrapolating the results of this sample as it may not be representative of all homes insulated under the Home Insulation Program. The inspections have to some degree targeted installations by firms with a poor compliance record.
